Annual General Assembly (AGM)

Negotiations

We have resumed Local negotiations and will start the Provincial negotiations this fall. The members of the negotiation committee have taken advantage of the quieter months of summer to prepare for these negotiations, with the help of our lawyers, based on the demands that we have received from you. Local 800 raiding

As explained on our Facebook page, on August 3rd, Local 800 filed a motion to be certified as the Union representing all LBPSB's Support Staff employees. We along with our lawyers are actively working with the agent from the Labor Board. Determining if that motion should be dismissed, as the Local 800 have not been successful in signing up most Support Staff employees, or whether a vote would need to take place will be decided in the next few months.

Many of you have been approached in a blatant inappropriate way and without consent by Local 800 representatives—at your homes and by phone, using your personal, confidential information to get you to sign a membership card with them. Know that the IASS disapproves of the way that Local 800 conducts its campaign which shows a total disrespect regarding the rights of privacy of Support Staff and their right not to be harassed or coerced into signing a membership card with Local 800. To this effect, the IASS has filed a formal complaint with the Board regarding the theft and the use of the confidential telephone coordinates, email addresses and home addresses belonging to Support Staff employees. This complaint is under investigation and the IASS will file a grievance for damages in the name of its members depending on the results of this investigation.
