NEGOTIATIONS

Local Arrangement

Negotiations regarding our Local Arrangement have gone well, a final meeting will take place before the end of the school year to solidify all that has been discussed and agreed upon.

Collective Agreement Negotiations

Negotiations for the renewal of the collective agreement are continuing with our lawyers and CPN-CA. As you may have seen in the News and as we expected, the date of June 30 that had been set by the government to complete the negotiations will not be reached. However, two negotiation sessions will take place before the end of June and other sessions will take place this summer during which we will continue to defend the rights of Support Staff employees in view of getting the working conditions and respect you all deserve.

We will make sure to give you an update at the start of the school year.

LEGAL MATTERS

Raiding by Local 800

Following the filing of a motion to represent the Support Staff of the Lester B. Pearson School Board, hearings were held before the Administrative Labor Tribunal. The purpose of these hearings was to determine the list of employees who can decide which association will represent you. IASS took the position of allowing as many employees as possible to participate in this important choice, while Local 800 wanted to restrict this list to their supporters.

We are awaiting the court's decision, which should be rendered this summer, we will keep you informed of the next steps once a decision has been made.

Confidentiality Breach of Personal Information of the Board's Support Staff

As we have already indicated to you, personal information of Support Staff employees was stolen and used, without permission, during Local 800's campaign to get membership cards signed. (Raiding Period)

IASS denounced this breach of confidentiality to the Board and its governance bodies and an internal investigation entrusted to an external person was set up. We contacted the Board to find out the progress of this investigation and we have been informed that 49 witnesses have been met so far and that following the meeting of additional witnesses, the investigator will be at the stage of writing his report.

As soon as the result of the investigation will be known, we will examine with our lawyers the possibility of claiming damages on behalf of the members affected by this breach of confidentiality.
