Wholesale Requirements

In order to be able to purchase our patterns at wholesale pricing you will be required to fill out our **Authorized Retailer Application Form** as well as provide us with a copy of your Resale Tax ID #. Once we have received and verified this information we will send you an email approving your application along with your Authorized Retailer Account #. Be sure to use your Authorized Retailer Account # on all orders and communications.

By setting up an Authorized Retailer Account and purchasing from Gingerberry Creek, you agree to all of our Wholesale Terms & Conditions and our Pattern Terms of Use.

Wholesale Order Requirements

Minimum Opening Order: 50 individual patterns

Minimum Reorders: 25 individual patterns

All opening orders **must** meet our Minimum Order requirement of 50 individual patterns. Any Opening Order or Reorder submitted that does not meet the Minimum Order requirement you will be notified via provided contact information and order will be placed on hold for up to 5 business days for order correction. If order is not updated to Minimum Requirements then order will be cancelled on the 6th business day.

All re-orders require a Minimum Order of 25 individual patterns. You are welcome to order more and take advantage of our 100+ individual pattern discount.

50-99 individual patterns @ \$5.70/pattern (40% discount off MSRP)

100+ individual patterns @ \$5.00/pattern (48% discount off MSRP)

Re-Order Options

25-99 individual patterns @ \$5.70/pattern

100+ individual patterns @ \$5.00/pattern

Wholesale Cancellation/Modification Policy

Orders may be cancelled and/or modified within 24 hours from placement of order.

Once orders have been charged and go into processing, you cannot modify and/or cancel the order.

If you should still cancel or modify your order after the 24 hour window, you will incur a 20% restocking fee of your order subtotal. Sorry, absolutely no exceptions.

Wholesale Payment Terms

All orders must be **pre-paid** via Credit Card, Debit Card, PayPal or Propay.

We do not accept Checks or Money Orders.

We will accept Cash for local orders only.

We accept Visa, MasterCard, Discover, American Express, PayPal, and Propay.

We will process all Credit and Debit Cards via Square or Propay. Transaction will show up on statements as Gingerberry Creek or Ginger Morgan.

If you prefer PayPal we can send a PayPal Invoice which you can then pay with your PayPal balance, bank account or credit card.

Note: If you choose to pay via your Bank Account in PayPal there will be a delay in processing your order. Once the payment clears the bank then your processing time will begin from that time.

Debit Card Notice: when debit card is processed for total order amount and if the funds should be insufficient, this could result in overdraft charges and other fees by your bank for which Gingerberry Creek is NOT liable.

Wholesale Order Processing

All wholesale orders are processed on a first come, first serve basis. We process orders during business hours, Monday through Friday. We do not process orders on Saturday, Sunday or any US Holiday.

25-99 individual patterns – Processing Time required is 5 business days
100-499 individual patterns – Processing Time required is 8 business days
500+ individual patterns – To be determined – Call for Processing Time required

We try and process all orders within the above required processing time frame from date of order placement. If for some reason we are experiencing longer processing times you will be notified of the delay.

Wholesale Shipping Terms

We ship most orders via USPS Priority Mail with Delivery Confirmation and Insurance from North Carolina. For very large orders we may choose to ship via UPS, FedEx or Best Way. Depending on your location shipping times may be longer than average shipping times. We cannot guarantee shipping dates or times.

Gingerberry Creek is not responsible for any order that is subject to Loss or Theft by shipping carrier. These incidences will be handled on a case by case basis.

We ship once a day by 12pm (EST), Monday through Friday. We do not ship on Saturday or Sundays or on any US Holidays.

50-99 individual patterns = \$35.00
100-299 individual patterns = \$45.00
300+ individual patterns = To be determined

Wholesale Return/Refund & Exchange Policy

Any defective or damaged merchandise by shipping carrier must be claimed by contacting Gingerberry Creek within 10 days from receipt of shipment. A claim will be filed with shipping carrier and it is important to hold onto all damaged merchandise and packaging as evidence until further advisement. Once claim has been initiated Gingerberry Creek will send out replacement patterns for all claimed damaged goods.

No Returns, Exchanges or Refunds. All Sales are Final.

Wholesale Backorders & Discontinued Products

At this time we do not offer a backorder program. If for some reason a pattern is not available or discontinued, then that pattern will be deleted from your order. If this causes your order to fall below the required minimum order amount your whole order will be held and notification sent.

Coupons, Specials & Discounts

Retail coupons, specials, discounts, and sale prices **cannot** be used towards a Wholesale Order.

Suggested Retail Pricing

We advise that all of our Paper Patterns are to be sold at the minimum MSRP price point. Since we also sell our patterns for retail on our website and at trade shows, we ask that you do not undercut our minimum MSRP price point.

Authorized Retailers are **NOT** allowed to offer our patterns as an E-pattern, Digital Download, PDF file, and/or Emailed Copy of the original pattern.
