

## **Wholesale Requirement Policy**

Wholesale purchasing is only available for Authorized Retailers in the contiguous United States.

In order to be able to purchase our patterns at wholesale pricing you will be required to fill out our **Authorized Retailer Application Form** as well as provide us with a copy of your Resale Tax ID #. Once we have received and verified this information we will send you an email approving your application along with your Authorized Retailer Account #. Be sure to use your Authorized Retailer Account # on all orders and communications.

By setting up and signing an Authorized Retailer Account and purchasing from Gingerberry Creek, you agree to all of our Wholesale Terms & Conditions and our Pattern Terms of Use.

# **Wholesale Payment Terms and Conditions Policy**

All orders must be **pre-paid** via Credit Card, Debit Card, PayPal or Zelle. We do not accept Checks or Money Orders.

We accept Visa, MasterCard, Discover, American Express, PayPal, and Zelle.

We will process all Credit and Debit Cards via Square or Propay. Transaction will show up on statements as Gingerberry Creek or Ginger Morgan.

If you prefer PayPal we can send a PayPal Invoice, which you can then pay with your PayPal balance, bank account or credit card.

**Note:** If you choose to pay via your Bank Account in PayPal there will be a delay in processing your order. Once the payment clears the bank then your processing time will begin from that date.

*Debit Card Notice:* If there are insufficient funds at the time the debit card is processed, there could be an overdraft charge and/or other fees by your bank for which Gingerberry Creek is NOT liable.

## **Wholesale Order Processing Policy**

Gingerberry Creek processes orders on a first come, first serve basis and during business hours only, which is Monday through Friday, 10am to 5pm (Eastern Time). We do not process orders on Saturday, Sunday, any US Holiday or any Scheduled Vacations.

25-99 individual patterns – Processing Time required is 7-10 business days 100-499 individual patterns – Processing Time required is 14-25 business days 500+ individual patterns – To be determined – Call for Processing Time required

Gingerberry Creek will try and process all orders within the above required processing time frame from date of order placement. If for some reason we are experiencing longer processing times you will be notified of the delay.

#### Wholesale Shipping Terms and Conditions Policy

Gingerberry Creek will ship most Wholesale Orders via USPS Priority Mail with Delivery Confirmation and Insurance, from Virginia. For very large orders we may choose to ship via UPS, FedEx or Best Way. Depending on your location shipping times may be longer than average shipping times. We cannot guarantee shipping dates or times.

Gingerberry Creek is not responsible for any order that is subject to Loss, Theft or Damage by the shipping carrier. All Wholesale Orders will include Shipping Insurance and any package that has been Lost, Stolen or has been damaged will require a Claim to be filed with the Shipping Carrier.

## **Lost, Stolen or Damaged Shipment Procedure**

- Please allow the allotted shipping time required for your Wholesale Order once you have received the Tracking Information.
  - o USPS Priority Mail normally delivers within 3-4 business days during regular times, peak holidays may take longer.
  - o USPS Ground Advantage normally delivers within 3-7 business days during regular times, peak holidays may take longer.
  - o UPS Ground normally takes 1-6 business days during regular times, peak holidays make take longer.
  - o UPS 3-day normally delivers in 3 days or less and is guaranteed by the shipping carrier.
  - o FedEx Ground normally delivers in 2-5 business days during regular times, peak holidays may take longer.
- If you have not received your package within 7 days from the date that delivery is projected, please contact Gingerberry Creek so that we may assist in finding out when to expect your delivery.
- If the package has not been delivered 10 days after expected delivery please contact Gingerberry Creek so that we may start the Lost or Stolen Package Investigation Claim.
- Once the package is determined Lost or Stolen by the Shipping Carrier, Gingerberry Creek will request Insurance Reimbursement from Shipping Carrier.
- Once Gingerberry Creek has received the Insurance Reimbursement from the Shipping Carrier we will authorize either to replace the Lost or Stolen Wholesale Order or authorize a refund on the Lost or Stolen Wholesale Order, all of which is at Gingerberry Creek's discretion.
- If the Shipping Carrier denies the Insurance Reimbursement Claim for any reason, Gingerberry Creek is not responsible for reimbursement or replacement of the Wholesale Order of any kind.
- If a package has been delivered Damaged it is very important to keep all packaging materials and to document the damage either by pictures or video. All Shipping Carriers will require proof of damage, so **DO NOT** discard any packaging materials.
- Please notify Gingerberry Creek immediately, within 5 days of date that package was delivered, if any of the contents of the package have been damaged. We will require pictures or video of the damaged packaging materials along with any damaged products.
- Once Gingerberry Creek receives documentation of the damaged shipment and product we will determine whether to file a Damage Claim with Shipping Carrier. Please allow 5 days for our Damage Claim decision.
- If Gingerberry Creek decides to file a Damage Claim with the Shipping Carrier, we will submit all documentation to the Shipping Carrier and wait the allotted time required by the carrier.
- If the Shipping Carrier agrees and accepts our Damage Claim we will wait for the Shipping Carrier to remit the Damage Claim Amount to Gingerberry Creek. At that time, Gingerberry Creek reserves the right to replace and ship any patterns that were damaged by Shipping Carrier or to submit payment reimbursement for said damaged patterns.
- If the Shipping Carrier denies the Damage Claim for any reason, Gingerberry Creek is not responsible for reimbursement or replacement of the damaged patterns of any kind.

• Any and All Shipping Carrier Claims need to be initiated within 14 days from date of delivery or projected delivery. If you do not contact us within those 14 days, we will not proceed with any Shipping Carrier Claims.

Gingerberry Creek ships once a day by 12pm (EST), Monday through Friday. We do not ship on Saturday, Sunday, US Holidays or any Scheduled Vaction.
