## **Executive Director Report:**

- Chris Myers reported that County Property Committee will recommend to the full County Board to build a new building (cost of new building would be \$4.6million) versus renovation of the current building. IHR will lose 15 offices in the destruction of the old building.
- The Transition Fair went very well with (85) lunches being served. A great time was had by all.
- The 708/377 Agency Funding applications for FY2019 are due Friday, May 24<sup>th</sup>. In June both budgets will be presented to the 708/377 Boards for approval.

- Megan DeMoss, OSF St. James Hospital, announced a new on-line service SilverCloud, available to individuals seeking help with depression, anxiety, stress and panic emotional issues. SilverCloud provides digital therapy from the comfort of their home. The service is available 24/7 on a computer, tablet or mobile phone at the OSF website.
- Jack Vietti named the three 708 Board members up for reappointment who are Debbie Studnicki, Rose Smith and Mark Donovan. It was moved by Vicki Day and seconded by Ed Legner to reappoint Debbie Studnicki, Rose Smith and Mark Donovan to the 708 Board for four years. Motion carried.
