#### **Executive Director Report:**

- Chris reported attending a meeting in Springfield last week. The DD Director told one of the ISCs that they would be receiving a lot of PUNS pulls next time due to the fact they have parent's night at school and may have up to 50 PUNS requests filled out in one night. Livingston County has had it shares of PUNS pulls. Seven people were pulled this year. One individual has not been found and another is refusing services that really need it. Another pull was welcomed by a grandmother of an individual who was pulled. She was so happy, she cried. It is hard to keep them all updated due to the fact they have moved or changed phone numbers. They must apply every 365 days. The PUNS pull will be done by how many years (once they are 18) on the list. Crisis is still available. However DHS has changed the criteria for PUNS to Seeking for Services or Planning for Services. Seeking services is for those that need services quickly. Planning services is for the caregiver over age 60 or looking for services within a year.
- In recognition of Direct Support Person last week, 708 Board gave Chamber Gift Certificates to all DSPs in the group homes and the day program. They were very much appreciated. The funding came out of the Service Development line item of the budget.

#### **New Business:**

DHS came out with the decision on ISC agency regions. There were seventeen ISC
agencies and DHS has consolidated them to twelve. Livingston County has been added
with twelve other counties. A map and instructions regarding the NOFO (notification of
funding opportunity) were included in this month's packet. Chris asked the 708 Board their
thoughts and suggestions regarding the NOFO. After much discussion the Board suggested
Chris contact Dennis Crowley and other knowledgeable persons who may guide Chris in the

best direction. There is not much time as the NOFO is due the first week in November. No action was taken. The topic will be brought back to the 708 Board at the October meeting.

### Safe Journeys:

• Susan Bursztnsky reported Safe Journeys will have a booth at the Dwight Harvest Days this weekend. Lindsay who has been the Sexual Assault case manager has accepted the position as full time Sexual Assault counselor. The State of Illinois is requiring all law enforcement sexual assault investigators to undergo 16 hours trauma training by December 31, 2018. MTU will be providing the training. By the end of next year all law enforcement who respond to sexual assault calls must have 8 hours of trauma training. Susan had some literature to distribute with their new name.
