- There were over 50 in attendance at the recently held Substance Abuse & Drug Court Training. Many area agencies were present. Teresa Diemer, IHR Substance Abuse Director, did an excellent presentation during the training. The Mental Health Board paid for the Subway sandwiches, IHR paid for the snacks and Probation contributed for the beverages.

- The ACMHAI Quarterly meeting will be held on September 23 & 24<sup>th</sup> in Champaign. The topic will be on Specialty Courts. If anyone is interested please contact Chris.
- Futures Unlimited is requesting the remainder balance of the POS funding in advance to "tide them over" until the state pays them. Chris created an amendment to the POS agreement, if the 377 Board approves, to advance Futures the remaining balance of their approved FY17 funding totaling \$94,339.00. It was moved by Mary Etta and seconded by Vicki to approve the advancement. Motion carried.
- Mental Health First Aid Training will be conducted at OSF in Pontiac. The Mental Health Board, OSF and Gibson City Hospital system have joined together to provide this extensive training to be held Wednesday, August 10 from 8-5. CEU's will be available.
