# **Executive Director Report:**

- Carol intends to attend the NACO meeting to be held in July in Pittsburgh, PA. The Association will pay \$500 of her expenses. The board is in favor of Carol attending this meeting.
- Carol reported on the PLATO learning system that is in several of the Livingston County school systems. Carol Gardner and John Mehlberg handle this program through the Youth Commission who receives the funding from DCFS. There possibly may be a credit recovery program for students over the summer at Tri-Point and at the ACHIEVE Center in Pontiac.

# **Old Business:**

- Carol spoke with Jordan Litvak, Regions 3 & 4 Director of Mental Illness, regarding the Mental Health (Recovery) Court subject. He has offered to present a workshop on the subject and bring in Dr. Freedman.
- The ACMHAI Spring Conference is in April and there is still time to register.
- The Open Meeting Act on line training is available on line to complete. Bob McCarty and Steve Tock have already completed the training and received their certificates.
- Vicki Day voiced her concern that the Triple P workshop being presented next week
  is only training 10 of the 30 OSF providers. Vicki feels in order to screen children it
  would be necessary for all the health care professionals to receive the training. This
  one class is only covering a small percentage. Joe Vaughan informed the board the

class can only accommodate up to 20 people at a time at the cost of \$30,000. The other 10 receiving the training are from Youth Commission and IHR.

### **New Business:**

- Carol reported that the DCFS programs will be cut by 9% for FY13. The Governor is is moving ahead with closure of the Jacksonville Developmental Center.
- The April 708/377 Board meeting will be held a week earlier on April 12<sup>th</sup> due to the ACMHAI Spring Conference.
