377 Board Meeting Minutes**

President Bob McCarty called the 377 Board meeting to order.

It was moved by Mary Etta and seconded by Vicki to approve the September 15, 2016, 377 Board minutes. Motion carried.

It was moved by Vicki and seconded by Mary Etta to approve September, 377 Board financial statements. Motion carried.

**Executive Director Report:**

- John Clemmer, Finance Resource Specialist for the county, emailed Chris with a report that due to a quirk in the PTEL law and the tax levy rules and regulations there is a strong chance we will receive an increase on the new budget to be approved at the November full county board meeting.
- Since Bob Walter has resigned from the 708 Board he will need to be replaced and also a 708 Board member will need to be appointed as Treasurer next month.

**Old Business:**

- None.

**New Business:**

- Karen Donovan, Futures Unlimited, presented a request to the 377 Board for two dishwashers. One for the Mary Beth Taylor Learning Center and the other at the Developmental Training program at Futures Unlimited main facility. Dishwashers would be a much more sanitary and allow for training of a new skill. It was moved by Vicki and seconded by Mary Etta to fund \$1,169 to pay for the two dishwashers. This funding would come out of the FY16 budget line item of Futures Unlimited. Motion carried.
- Karen's second request to both the 377 & 708 Boards is to fund a pilot program for 12+ individuals who are on the PUNS waiting list. This would allow these individuals 4 hours a week of the person's choice such as group activities, LCAR activities, volunteer activities, participating in community clubs, visiting local sites, etc. This would be 26 week program beginning November 1. Total funding request for the pilot program is \$4,160. It was moved

by Vicki and seconded by Mary Etta to fund the remaining money in the 377 FUI budget for the program. Motion carried. It was moved by Steve and seconded by Mark to fund the remaining balance of the pilot program from the 708 FUI line item of the FY16 budget. Motion carried.

- Chris recognized Margee Morrison, director of ADV/SAS, upon her retirement. Margee gave 18 years of service to the agency. Chris presented Margee with a beautiful fall wreath from the board. Margee thanked everyone. A retirement party will be held for Margee on November 3, 2016 at the The Eastwood Golf Course in Streator.
- Chris introduced Rose Smith to the boards. She is very interested in serving on the 708 Board. Rose told a little bit about herself. She has been a teacher for the past 37 years in public education. She was the administrative assistant to the director of LCSSU. Rose continues to work a few hours in the Prairie Central School District. It was moved by Ed and seconded by Debbie to serve the remainder of Bob Walter's term until May 2017. Motion carried. This appointment will now go before the county board meeting in November for their approval.
- Chris reported that DHS Division of Developmental Disabilities with representatives of the 17 Independent Service Coordination (ISC) agencies on September 1<sup>st</sup> to inform them of the Division's intent to seek competitive proposals for future ISC contracts. The Division believes this action is in the best interest of the State and the individuals served. Chris gave the deadlines that the Division has proposed. She would like the board's input. There are a lot of unknowns until the Notice of Funding Opportunities (NOFO) is posted on November 30<sup>th</sup>. One of the unknowns is the state wants to change the map of regions and cut back on the 17 agencies having them consolidate down to an unknown number. Chris has been in numerous phone conferences with the other ISC agencies. Next year the individuals ISPs will be done by the ISC's instead of the agency providing the individual's service.

**Agency Comments:**

**Institute for Human Resources:**

- Joe reported Snowflurry will be held on Nov. 5<sup>th</sup> in Odell for all 3<sup>rd</sup> and 4<sup>th</sup> graders interested. There are around 50 high school students volunteering their time to the event.

**Futures Unlimited:**

- Karen did not have much to report other than their CARF survey went very well. There is still no state budget.

**ADV/SAS:**
