#### **Executive Director Report:**

- Carol reported she attended the ACMHAI two-day conference held in Decatur. Dennis Crowley hosted the conference. He gave a three hour presentation on the first day and another hour the second day on the topic of Managed Care. Carol reported that he did an excellent job.
- Carol spoke on some of the governor's plans regarding the budget.
- Kevin Casey has left the DHS DD director position and Greg Fenton has been named as his replacement.
- Tony Records will retire as Ligas monitor in October.
- Carol reported that the average cost of an individual living in a state operated facility is around \$247,000 a year versus \$55,000-\$65,000 a year for an individual living in a CILA home.
- Carol met with Louis Lyons this morning to discuss the formation of a new group called Livingston County Cancer Fund. There is a 50/50 raffle and a cookout planned during the Red Carpet Festival. The drawing will be held on May 16<sup>th</sup>. The money raised will all stay local in Livingston County.

#### **Old Business:**

• Carol reported that Ken Beutke of OSF has taken a position at the Ottawa OSF hospital. He was a key member of the LCCN. The executive members met with Rich McGourty yesterday and sustainability was the main topic.

- The Boys & Girls Club of Prairie Central is requesting an additional \$3,000 for the Chatsworth summer program. The 708 Board had approved \$1,000 at the February meeting. However, an additional \$3,000 would be needed to run the program for up to 45-50 children. Last year the 708 Board approved \$5,000 for the program. Nicole Winterland provided a budget for the board to review. After a brief discussion it was moved by Laura and seconded by Ed to approve an additional \$3,000 to fund the Prairie Central Boys and Girls Club summer program in Chatsworth. Motion carried.
- The hallway carpet continues to unravel which is a safety issue. Carol has discussed the condition of the hallway carpet twice with Chad Carnahan, the building maintenance manager. He has not provided any answers as of today. Vicki suggested calling Mike Ingles, property chairman, for the county board.
