President Jack Vietti called the 708 Board meeting to order.

It was moved by Laura and seconded by Ed to approve the April 11, 708 Board minutes. Motion carried.

It was moved by Margaret and seconded by Laura to approve the April check listing. Motion carried.

It was moved by Ed and seconded by Laura to approve the April, 708 Board financial statements. Motion carried.

Executive Director Report:

- Carol reported some good news. The Mental Health Board employee insurance rates will remain the same for the new fiscal year
- Carol read a thank you note written by a single mom of a DD son. She was overwhelmed with the support of the Mental Health Board staff.
- There were 237 people on the PUNS list for Livingston County that have not received services.
 The state of Illinois has 22,000 on the PUNS list. The PUNS list for Livingston County has been reduced to 106 people. The numbers have been reduced for several reasons. Some have received services, some have refused services, some have died and some have moved out of the area.
- Carol and staff attended a meeting last week. The federal monitor was there.
- She gave a report on the payment status from the state. It could be September of after that the agencies will have to wait until payments will be received.
- OSF has entered into an agreement with the accountable care organization.
- Carol spoke about the Medicaid Match program.

Old Business:

- Carol gave an update on Mental Health Intervention Probation Program. States Attorney Seth
 Uphoff was in attendance at last Monday's meeting. Maybe there is hope that he will get on board
 with the program. There have been many screenings done. Twelve individuals have been denied
 due to not meeting the criteria of the program and two have been accepted.
- The LCCN program meets almost every Friday. About 3 weeks ago they met with the Children's Foundation people. They are very impressed with how well the program is working. There are two more years left of the grant money.

New Business:

- Discussion was held on the financial plight of our agencies. DHS has frozen funding until a new budget is passed. Funding may not start again until August or September. It was moved by Laura and seconded by Margaret to approve the advance of remaining FY13 Funds in Futures Unlimited and IHR contracts. Amendments to the 708 Board Purchase of Service Agreements with both providers requires that billings for services will continue. Any funds not billed out will return to the 708 Board. Motion carried.
- Carol is requesting the 708 Board to approve \$10,000 funding out of the service development line item to fund an IHR therapist in the Dwight OSF office. It was moved by Vicki and seconded by Ed to approve \$10,000 for OSF office in Dwight an IHR therapist provide counseling services for Dwight and the surrounding communities. The \$10,000 would come out of the Service Development line item of the budget. Motion carried.
- The Sheriff's Department contributed \$3,000 to help fund the Alternative School. The Apollos Camp-Bennet Humiston Trust donated \$25,000 as well for the next school year.
- Carol asked the Board if they had any questions regarding the FY12 Annual Report. Carol will
 present the report to the full County Board at tonight's meeting. It was moved by Ed and
 seconded by Margaret to approve the FY12 Annual Report as presented. Motion carried.
- Mary Etta gave a brief report of the ACMHAI Spring Conference.
