President Jack Vietti called the 708 Board meeting to order.

It was moved by Paul and seconded by Laura to approve the August, 708 Board minutes with the revision that Steve Tock <u>was not present</u> and Joan Bullard is a <u>candidate for County Board</u>. Motion carried.

It was moved by Steve and seconded by Vicki to approve the August, 708 Board financial statements. Motion carried.

# **Executive Director Report:**

- There was a brief discussion regarding the FY13 budget and the levies.
- Carol attended the Recovery Court training in Decatur along with 6 others from Livingston County.
  The next meeting will be on November 8<sup>th</sup> to plan on getting Recovery Court up and running in
  Livingston County. They hope that the new States Attorney will attend the meeting. Joe has
  written a policy and procedure for the program. Judge Bauknecht is very excited about the
  program. Carol hopes that eventually Veteran's Court could be included in this program as well.
- Carol also attended the ACMHAI quarterly meeting was also held in Decatur the day before the
  Recovery Court training. The Developmental Disability programs did not receive cuts in the new
  budget. Sixteen people from Livingston County were pulled from the PUNS list for services.
  Kevin Casey, Director of DHS Developmental Disabilities, spoke at the ARC meeting last
  Saturday. Only 50 individuals have been relocated of the Jacksonville Developmental Center.
  The date has been changed from Oct. 1st to Jan. 1st. Murray Developmental Center in Centralia
  will be closed next. Singer Mental Health Center is also targeted for closure.
- Carol gave a brief report on LCCN and presented the LCCN Newsletter that was distributed to all at the meeting. Triple P will hold another training for OSF staff.

#### **Old Business:**

• The FY13 Budget cannot be approved until the county has set the levy. The County Board has approved a 1% salary increase for FY12 to all employees retroactive to January 1, 2012. The Mental Health Board Budget will need to be amended to account for this additional amount. Next fiscal year will be a 2½ % salary increase approved by the County Board. It was moved by Ed and seconded by Steve to amend the FY12 Budget to reflect the 1% salary increase that the County Board approved retroactive to January 2012. Motion carried.

#### **New Business:**

 Carol presented a proposal to the board for an analysis of our technology system and the policy and procedures related to it. It was moved by Vicki and seconded by Steve to approve the proposal from Sol Roberts-Lieb, U of I Technology Specialist, to do an information technology system assessment up to \$1,000. Motion carried.

# **Agency Comments:**

#### **Futures Unlimited:**

• Brian Blossom reported that after he sent out the Futures Board report he received a memo from Kevin Casey regarding an increase from 20% to 25% for fringe benefits for employees of agencies with group CILA rates. They also will build in incentives for CILAs with 4 or fewer beds in home. This will help Futures Unlimited quite a bit because they are more expensive to operate. The rate increase is to be effective immediately. DHS is also offering incentives to agencies that will agree to take on 8 or more individuals from state operated facilities. Thus speeding up the process to close these state operated facilities. Futures Unlimited's Board has decided to only serve Livingston County individuals or individuals that have ties to Livingston County.

### **Institute for Human Resources:**

- Joe reported that Beth Robert, nurse practitioner, is taking on more cases due to the expansion of psychiatric services. Dr. William Puga has been named Medical Director.
- CARF 3-year accreditation is next week. This accreditation is to confirm that IHR is living up to the national standards. This will be a 2-day survey.
- Since it is not certain that Dwight Correctional Center will close, IHR will send an employee to
  continue the program working with the women who have either killed their children or severely
  harmed them. That program will resume next week.

#### ADV/SAS:

- Margee reported that Domestic Violence Awareness month is in October. She will send
  information regarding the activities that will be scheduled. A group of agencies meet monthly
  regarding Domestic Violence against men & women and the developmentally disabled of the
  community.
- United Way kick-off is this week. Dr. Reid Petit and his wife are heading up the fund-raiser this
  year.
- They have been requested to go to Dwight Correctional Center on Friday nights for the month of October to discuss domestic violence and the effects it has on adults and children.
