RESTATED ARTICLES OF INCORPORATION (JANUARY 2026)

OF

BUTTE TRAP CLUB, INC.

Pursuant to the provisions of the Mont. Code Ann., Title 35, Chapter 2, Part 2 (2023) undersigned corporation hereby executes the following Restated Articles of Incorporation for the BUTTE TRAP CLUB, INC.

I.

The name of the domestic non-profit corporation is BUTTE TRAP CLUB, INC.

II.

The period of its duration shall be perpetual.

III.

This corporation is organized for the purpose of providing facilities primarily for training and practice for, or competition in, the international sport of trapshooting and trapshooting events. Incidental to this purpose the corporation shall promote, foster, and encourage the art and use of handling firearms; improve the standards of the appreciation for international amateur trap shooting, and educate its members and the general public concerning firearms safety and control.

IV.

This corporation shall NOT be operated for profit and SHALL be operated in such a manner that no part of any income or property of this corporation shall inure to the benefit of, or be distributable to, any officer, director, member, or any other private person, except that the corporation shall be authorized: and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 2024.

V.

Upon the dissolution of the corporation, the officers and Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation, or distribute such assets to such organization as shall be at the time qualified as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 2024 as the officers and Board of Directors shall determine. The disposition of any remaining corporate assets shall be determined by a vote of the membership, including officers and Board of Directors of the corporation. At least two-thirds (2/3) of the membership of BUTTE TRAP CLUB, INC. must vote either in person or by proxy in order to determine the sale or dissolution of the corporation for any reason. A further requirement for members voting on a sale or dissolution is that they must have been a member of the BUTTE TRAP CLUB, INC. good standing for five (5) consecutive years immediately preceding such vote to sell or dissolve the corporation. Each member shall have only one (1) vote.

VI.

The corporation has no capital stock and has no intention of having capital stock. In lieu thereof the corporation shall have one (1) class of membership and each member shall have only one (1) vote. The restriction pertaining to voting on the sale or dissolution of the corporation set forth in paragraph V hereof shall apply only in the case of sale or dissolution of the corporation.

VII.

The registered office of the corporation is 70 Basin Creek Road, Butte, Montana, 59701, and the name of its registered agent at such address is Tim Cassidy, 4 Bittersweet, Butte, Montana 59701.

VIII.

The corporation shall have a President, Vice-President, Secretary, Treasurer and Field Captain, and a Board of Directors, and they shall constitute the Executive Committee. There shall be at least five (5) members comprising the Board of Directors or such other number as the By-Laws of the corporation may from time to time provide. The Board of Directors shall have full power to make any and all rules and regulations for the maintenance and management of any property owned by the corporation, including its shooting grounds at Butte, Montana, as it may desire, provided however, that all such rules and regulations may be subject to repeal or revision at the annual corporate meeting. Any director may be removed from office by the affirmative vote of two-thirds of the directors as fixed by the By-Laws at any meeting of the Board of Directors.

IX.

These Restated Articles of Incorporation (January 2026) have been adopted in the following manner:

- A. That a meeting of the Executive Committee was held on January 18, 2026, and by majority vote the Executive Committee determined the restatement of articles required a vote of the membership under Mont. Code Ann. §§ 35-2-226(2) and (6) and further approved recommendation of these Restated Articles to the membership.
- B. That following written notice of amending its Articles of Incorporation to its members by regular mail pursuant to Mont. Code Ann. § 35-2-530, an annual meeting of the membership was held in Silver Bow County, Montana on January 18, 2026. By two-thirds (2/3's) vote of members present approved the Restated Articles of Incorporation (January 2026) pursuant to Montana law and, specifically, Mont. Code Ann. §§ 35-2-226(6) and 35-2-223(1)(b).
- C. The officers and directors were authorized and directed by the membership to file the proposed Restated and Amended Articles of Incorporation and that they were duly adopted as required by law.

X.

These Restated Articles of Incorporation correctly set forth the Articles of Incorporation of this corporation as heretofore amended and supersede the original Articles of Incorporation and all amendments thereto.

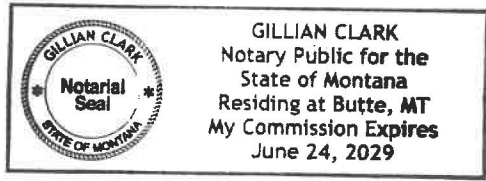
