

# Minutes – Fall 2022 Meeting October, 29, 2022

Call the meeting to order.

Arlene read the minutes from the April 2, 2022 meeting.

We have \$4,760.42 in the bank as of October 28, 2022.

#### **New Business**

- Tammy Mattingly made a motion that each membership allows that family to harvest the legal limit set by AGFC. Ex: husband is member, he and his spouse can harvest five deer between them. Youth not affected by limit.
   Motion seconded by Amanda Green.
   Vote failed.
- Rex Davis made a motion that we remove the rule voted on in Fall 2022 that said non-paying family members such as spouses can only harvest one deer per year and each deer past one can be purchased at \$50.
   Motion seconded by Bobby Green.
   7 for and 2 against. Vote passed. (ByLaws will be reinstated to previous rule)
- 3) Rex Davis made a motion to change the guest rules. Current rules were: Members are allowed two guests per day. Individual guests are limited to 3 days per year. (Deer or Turkey Season) Once a guest has harvested a deer or turkey, they may no longer hunt.

His recommendation was for a guest to be anyone on the lease small game hunting, hog hunting, deer hunting and turkey hunting. The rule will remain where members are allowed two guests per day. Guests are limited to 3 days per year. Once a guest has harvested a deer or turkey, they may no longer hunt.

It was discussed and anyone accompanying a hunter on the lease, including hog hunting, is considered a guest and must pay a guest fee.

The current penalty in the ByLaws are: A member found hosting a guest without purchasing a guest pass from an officer or director will be assessed a \$100 fine. Second violation of the guest rules will result in the member losing their membership in Toler Lake Hunting Club.

Motion seconded by William Fitzgerald. Vote passed unanimously.

- 4) Amanda Green made a motion that if you hold an officer position in an adjoining lease, you cannot hold an officer position in Toler Lake Hunting Club.

  Motion seconded by Bobby Green. Vote passed.
- 5) Marcie Edwards made a motion that dogs in a camp must be on a leash or in a pen at all times.
  - Motioned voted on was: Dogs in a camp must be leashed or in a pen. Free roaming dogs are not allowed in any camp on Toler Lake Hunting Club. First offense will be a fine of \$50. Second offense of this rule will be grounds for dismissal. Motion seconded by Christy Reilly. Vote passed.
- 6) Arlene Green made a motion that No member may hunt a stand they do not own without permission of the owner.
  - Motion voted on was: No member, their guest or non-paying family member may hunt a stand they do not own without permission of the owner. If caught hunting a stand without permission, the member will be fined \$50. Second offense of this rule will be grounds for dismissal.
  - Motion seconded by Mike Davison. Vote passed.

Mike Davison made a motion we adjourn and Bobby Cohen seconded it.
