the undersigned and/or others of firearms and	ammunition, archery equipment, range equipment, targets and
related devices and materials. This release is g	given on behalf of myself: my heirs, successors, executors,

I accept and assume for myself, my heirs, administrators, executors and assigns, the full responsibility for any and all such damage, injury or death that may result.
- e) This agreement is governed by the applicable law of the Commonwealth of Massachusetts. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
