Awards: Medals/Ribbons for Primary, pre-Premier and Premier; cash awards for oldest Premier group. Aggregate trophies given in each age group except Primary.

RULES: SOBHD rules will govern the competition. Dancers must be ready to dance when event is called and must dance in numerical order. First to enter, last to dance. Dancers must compete in their own category. Age groups to be determined on receipt of entries. Dancers must fill in for reels when asked to do so. Dancers must remain in costume to receive awards. Dancers must present a valid SOBHD 2019 registration card when picking up their numbers. Any dancer without a card must pay a \$5 penalty and have any awards withheld until the card is produced. Cloth numbers must be returned at the conclusion of the competition, and it is the dancer's responsibility to return them in the same condition as they were received or a \$10 fee will be incurred.

NOTE: As per the ScotDance Canada "Child and Youth Abuse Prevention Program" policy, dancers will not be permitted to change in public areas. We ask all dancers and parents for their cooperation in this regard and to please use the designated change areas.
