2024-2025 Budget & Assessment Change

- Creekside Oaks has made several major improvements in the last year which has included the submeters and the paint/fence project. We have another large capital improvement, a sewer system projectm, that will comprise of replacing portions of the old pipes in the common area, adding clean-outs where needed, and replacing the main pipe that runs under Deep Well and Bay Tree Lane. We have put \$300,000 into reserves as a placeholder for this project, however it doesn't include any post project landscaping, nor do we yet have a real number for this needed work. Due to this unfunded capital expense and to bolster the reserves for potential infrastructure demands, the board voted to increase our reserves by 20%.
- Therefore, our HOA dues will increase from \$1210 to \$1452 beginning November 1st, 2024.
- If your payments are not set to automatically update, please be sure to update the payment amount.

Gate Code Change—October 1st

Be sure to use the new gate code which became effective, October 1st.

Pond

- The association contracted with Solitude Lake Management for maintenance.
- The initial blue color is a result of the dye that blocks sunlight and helps control the algae and is expected to moderate over time.
- The time to return the ponds to a steady state is about two and up to three months. The hope is that they don't need to be drained.

Earthquake Insurance

 The association is planning on a townhall in late October or early November on the options for earthquake insurance. It is certainly a hot topic and important to many members. The Committee and Board will consider feedback after this townhall.
