# Earthquake Insurance—Motus Presentation-Thursday 12/5

- The association is retaining the \$10M earthquake policy. 100% coverage would require an approximately \$58M policy.
- Some homeowners have expressed that they desire more earthquake insurance coverage.
- The association has joined Motus which enables individual homeowners to purchase additional and more comprehensive coverage.

# **Ponds**

- The blue color is a result of a dye that blocks sunlight and helps control the algae and is expected to moderate over time.
- The time to return the ponds to a steady state is about two additional months. The hope is that they don't need to be drained.
- The fountain height is being affected by clogged filters and the Board is working with the new pond maintenance contractor on a permanent addition to the filter to facilitate more frequent flushing.



Pay Assessmen


