TERMS:

1. Set-up can begin Thursday, August 27th 2:00 p.m. – 9:00 p.m. and Friday 28th at 9 a.m. – 12:00 p.m. **SET-UP MUST BE COMPLETED BY NOON FRIDAY.** You will be provided with two gate entry passes per day, which can be obtained from the office or the CAS Director in the arena during set-up.
2. All Vendor booths must be manned and/or on display for the following hours of operation:

FRIDAY: 12:00 – 10:00pm SATURDAY: 10:00am -10:00pm SUNDAY: 10:00am – 6:00pm

3. **NO VEHICLES** will be allowed on site during Fair hours. **THIS INCLUDES SUNDAY!** Take-down of your booth may not begin until the fair closes on Sunday.
4. No refunds will be made after August 12th, 2019.
5. Tables and chairs are available to exhibitors however they are limited and availability is not guaranteed.
6. ***All vendors must carry their own liability insurance in the amount of \$1,000,000. The Cobden Agricultural Society must be named as an additional insured. Proof of insurance must be attached to this application.**
