# C. Discussion/Action Topics

#### 1. Mainstreet Project

Mainstreet Arts & Cultural District is requesting to have the City of Gallup contract for the 2025-26 Fiscal Year. Based on the contract with the State of N.M., the minimum required contribution is \$52,750 for the Core & Additional Services listed in the Scope of Work. The Core Services and Additional Services are attached. Mainstreet is requesting funding of \$75,000 for the year.

Gallup currently has \$41,000 left in budgeted charitable funding after the last council action.

The City through Lodger's Tax currently funds Mainstreet \$30,000 for the Levitt Concert Series which does meet the standards.

#### Recommendation:

- 1. Continue funding the Levitt and contribute \$22,750 to \$45,000 to meet the minimum obligation of \$52,750 or requested amount of \$75,000.
- 2. Fund the \$52,750. \$41,000 from the charitable fund with additional funding from other approved funding sources based on CFO recommendation.
- 3. Not fund the project.

If the project is funded, instead of standards to work towards, I suggest achieving actual benchmarks to be considered in the future. These can include:

- \* # of apartments opened in the Mainstreet area.
- \* Provide "X" number of events to have community gatherings centered around arts, culture, and local business above and beyond Levitt Concert Series.
- \* Create "X" number of art installations based on #2e.
- \* Through the support, establish a new business (entrepreneur) in the Mainstreet area.

Fiscal Impact: \$22,750 - \$75,000

Recommendation: Approve funding for Mainstreet for 2025-26 FY through option

1 or 2 with benchmarks.
