This shall include warm-ups, all Summer Slacker Draft League games, breaks in games, post game handshakes, etc. The player understands that he will be subject to suspension and/or expulsion from the Summer Slacker Draft League for violation of this rule.

3. For reasons of safety, the Summer Slacker Draft League RECOMMENDS THAT ALL PLAYERS WEAR A USA HOCKEY APPROVED **FULL FACE CAGE MASK**. The Summer Slacker Draft League cannot attest to the amount of protection afforded by any other method of facial/dental protection other than the full-face cage mask. The player assumes all risk of personal injury, which may result while participating in the Summer Slacker Draft League with the above-designated method of facial/dental protection. The player will not hold the Summer Slacker Draft League, any Summer Slacker Draft League officials, management, owners, nor the proprietor or employees of any ice facility used by the Summer Slacker Draft League, liable for any injury which occurs with the use of the above-designated method of facial/dental protection. **If any player elects to play without full face protection they are assuming all risk of injury and liability. Any player who receives any injury to their head, face, eyes, ears, nose, mouth or any other part of their face, cannot hold the Summer Slacker Draft League to any liability. The player removes the Summer Slacker Draft League from any and all liability from damages for any injury sustained.**

4. Summer Slacker Draft League does not warrant or guarantee the quality of any equipment used in any Summer Slacker Draft League activity.
