- 5. Sending anonymous messages of any kind.
- 6. Altering or forwarding personal communication without the author's prior consent.
- 7. Using profanity or obscenity.
- 8. Using the network or Internet to access a file that contains pornography, inflammatory material, inappropriate material, or any material not specifically related to the instructional lesson, objective, or assignment.
- 9. Using the network to send and or receive inflammatory messages.
- 10. Ordering services or merchandise from other agencies that have Internet access. Heartwood Christian Academy shall not be held responsible for any transactions or be liable for any cost or damages arising out of the actions of students or merchants.
