(Please note that AKC charges a small processing fee for online entries.) During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: Wednesday 200 runs Online and 400 Paper. Thursday & Sunday 350 runs Online and 700 Paper. Friday & Saturday 350 runs Online and 1050 Paper. If either form of entry (paper or online) has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either one accordingly.

## NOTICE TO EXHIBITORS

**THE SAFETY OF DOGS** is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

**SHOW HOURS** 11:00 AM to 7:00 PM Local Time (EST) on Wednesday and from 7:00 a.m. to 7:00 p.m. Thursday thru Sunday.

**RETURNED CHECKS** do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.

**TELEPHONE, EMAILED, FAXED, INCOMPLETE AND UNSIGNED ENTRIES** cannot be accepted.

**ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS** without the Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE**. **Unsigned entries or entries missing information will be returned.**

**ENTRIES RECEIVED WITHOUT FEES** will not be accepted. **Entry fees:** \$25.00 first entry, \$19 for each additional entry of the same dog on the same day (includes \$3.50 AKC recording fee for first entry and \$3.00 entry for every additional run) **NEW!!!! (Junior Handler Entry Fees: \$15.00 First entry, \$12.00 for 2<sup>nd</sup> each additional runs of the same dog on the same day.**

Junior Handler's must have an AKC Jr Handler number and dogs must be owned or co-owned by the Jr Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including the corresponding step and half relations, or by a permanent member of the Jr Handler's household.

**Greater Louisville Training Club, Inc., its agents etc.,** assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assumes no responsibility for injury to children.

**JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS.** The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. If handlers have a ring conflict and so inform the gate steward, every effort will be made to accommodate you.

**BITCHES IN SEASON** are not eligible to participate. There will be a refund of entries due to bitches which come in season after trial has closed and for dogs injured prior to March 16 upon written certification by a Veterinarian minus a \$5 per class fee. *An injury is any wound or damage to the body resulting from physical activity. Some common injury types are: cut, abrasion, fracture and burn. Sprain and strain injuries to muscles, joints and connective tissues are classified as injuries.* Notification must be in the hands of the Trial Secretary **no later than one half hour prior to the start of the first class of the day of the trial (March 16<sup>th</sup>).**

**ALL DOGS MUST BE ON LEASH AT ALL TIMES EXCEPT WHEN IN THE RING OR IN THE DESIGNATED WARM-UP AREA.** Exhibitors are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the trial committee, be asked to leave the show site. In such cases, no refund of any fees will be made. All dogs present must be held on leash or confined to their crates at all times except when in the ring or when in the designated agility warm-up area. **All exhibitors must pick up dog waste everywhere on the show grounds.** The site will be monitored and offenders will be asked to leave. In such cases, no refunds will be made.

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive or blind dogs or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are ineligible to participate.

### **HEIGHT DIVISIONS:**

Exhibitors are responsible for entering the proper height divisions. In the Regular classes, dogs may be entered at the jump height for which their measurement qualifies them or a higher jump height, if the exhibitor chooses. In the Preferred classes, however, dogs must run in the jump height for which their actual measurement qualifies them.

**MOVE-UPS:** Dogs may be moved up at the request of the owner as a result of qualifying for an agility title, provided that the request is made to **the Trial Secretary in writing.** (E-Mail is acceptable.) All move-ups for the weekend must be received by the trial secretary no later than **WEDNESDAY, March 9, 2022 at 6PM.** Day to day move-ups will be accepted over the weekend at the GLTC trial. No moving down or changing or height after closing except as specified in Chapter 1 Section 21 of the AKC Regulations For Agility Trials.

**IF you miss the WEDNESDAY deadline I can NOT take emailed move-ups after that time. You may come on the first day of the trial (Wed., March 16<sup>th</sup>) and fill out a form in person or have someone turn it in for you in person to move up for Thursday thru Sunday. Nothing after the deadline can be done for Wednesday but at least you can move up for the rest of the weekend if you are entered, again, it must be turned in by yourself or someone for you at the trial.**

## IMPORTANT SUGGESTION IF REDEEMING VOUCHERS!!!!!! Please read!

## Classes Offered:

**Wednesday:** T2B, Exc/Master Standard and Exc/Master JWW ONLY is offered.

**Offered Thursday thru Sunday:** Novice A & B, Open, Excellent & Master Standard, Jumpers w/Weaves and FAST classes in Regular. And Novice, Open, Excellent & Master Standard, Jumpers w/Weaves and FAST classes in Preferred.

T2B Regular and Preferred are also offered all four days.

**Offered Thurs, Fri and Sat ONLY:** Premier Standard and JWW in Regular and Preferred.

## COVID

**GLTC will follow all state and facility mandates regarding Covid 19. At this time we will not be requiring a mask while running or requiring a waiver to be signed. Wearing a mask is optional at this time.**

## Class Changes Effective January 1, 2020

**Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day**

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed.

Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

**A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.**

When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1<sup>st</sup> run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

### Entering For Exhibition Only (FEO)

**As of January 1, 2020**, For Exhibition Only may be offered at the option of the host club. FEO will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FEO will allow exhibitors to work with their dogs in a trial environment. **FEO is only allowed in the Time 2 Beat and FAST classes.** FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. **Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.**

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
  - Toys must be non-audible
  - Toys may not leave the handler's hand
  - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

***(Note: This section only needs to be published in the Premium List if the Club is offering FEO.)***

### Fix and Go On (FNG)

**As of January 1, 2020**, FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.
