### **Professional Profile**

Captain Lawson-Earley is a Master Mariner who sailed in command of crude oil tankers from AFRAMAX to VLCC. Since coming ashore, he has worked as a Marine Superintendent, Marine Consultant, Marine Advisor, Marine Manager for an LNG Shipowner, Marine Terminal Manager for LNG regasification terminals and as a Marine Technical Instructor.

As an independent Marine Consultant Captain Lawson-Earley provides expertise in LNG Shipping operations; oil, chemical and gas tanker shipping operations; port and marine terminal operations; navigation; seamanship; ship-handling and offshore operations. He also covers charter party disputes, S&P contract disputes, cargo claims and disputes, investigation of marine incidents and accidents, including provision of reports, expert opinions and expert witness testimony if required. With experience in LNG, oil, chemical, gas tanker and marine terminal operations and management Captain Lawson-Earley provides proactive services including safety analysis, risk assessment, and project feasibility studies.

He is a Marine Technical Instructor responsible for the development and delivery of STCW compliant and bespoke short courses in the classroom, using simulation, online or at clients premises, covering Gas, Oil and Chemical Tanker operations, Gas as Marine Fuel, Port and Terminal Operations, Ship and Port Security, Ship to Ship (STS) cargo operations, Crisis Management, and Human Element at Operational and Management Level.

Captain Lawson-Earley has firsthand operational experience of refrigerated cargo ships, container ships, patrol vessels, high speed ferries, crude oil, black oil, product and gas tankers, offshore support vessels, LNG terminal development projects and management of LNG marine terminal operations. Captain Lawson-Earley has conducted audits and inspections of ports, marine terminals, ship owners, ship managers and ship operators for energy majors based upon OCIMF MTMSA and TMSA Programs and is familiar with the requirements of OCIMF SIRE Program, OVID database, CDI Inspections and IMCA CMID.

As Marine Manager and Marine Superintendent, Captain Lawson-Earley was the Designated Person (DP) and Company Security Officer (CSO), he is familiar with the requirements of the International Safety Management (ISM) Code and International Organization for Standards (ISO) quality, environmental and safety management systems such as ISO 9001, ISO 14001, and ISO 45001/OHSAS 18001.
