2023 Ellis County Contracted Joint Election - May 6, 2023

Ballot Information, Website, Canvass Reports, Tabulation Election Results

Notice of Election (Sec. 4.002) The Joint contract states (Sec.I.F.) that the Elections Office will post a "Joint Election Notice" in each newspaper published in the territory of each participating entity. If you are having a special proposition election, you will need to publish your own notice in your local newspaper since Section 4.004(b) of the law requires you to state each proposition measure to be voted on. Each entity is held responsible to post a legal notice and to check their Charter rules for any other requirements of posting the Notice of Election and to speak with your legal counsel. New Law HB2721 (2015) Requires the election notice to be posted to website and bulletin board (Sec. 4.003b), if political subdivision maintains a website (Sec 85.007). See note in Advisory 2022-37.

Notice of Bond Elections

Entities holding bond elections must provide additional notice per Section 4.003(f) added by SB 637. A debt obligation order under Section 3.009 must be posted: 1. (Elections Dept will handle) On Election Day and during Early Voting by personal appearance, in a prominent location at each polling location. 2. (Entity will handle) Not later than the 21st day before election day, in 3 public places.... 3. (Entity will handle) During the 21 days before election, on the entity's website.... See full notation for Bond Notices and the required information for the Order/Notice of Bond Election in the SOS Election Law Calendar. Elections Dept will place 3 ring binders in each EV and ED polling locations of your provided bond notice materials. Materials needed by week of March 06, 2023. Elections Administrator will sign an affidavit for "Posting of the Bond Election" and we will send 3 original copies to each entity after the election.

Wording for Ballot (Propositions)

- We request Ballot text wording for any Charter Amendment and/or Proposition to be received by Monday, Feb 27, 2023.
- Propositions for local political subdivisions must assign a unique letter of the alphabet to each local proposition that will appear on the ballot (Section 52.095, as amended. Election Advisory No. 2017-06) (ie. City of ______ Proposition A or ______ I.S.D. Proposition A etc.)
- ***Text must be in English and Spanish; upper and lower case sentence style; NO all uppercase text accepted; send in Word Doc.***

<u>Candidate Names for a regular election filing deadline</u> (Note: dates are different for a "to fill a vacancy" election pending when the notice to file was posted. See SOS advisory)

- Candidate filing deadline for Regular Election Friday, Feb 17, 2023 at 5:00p.m. (Filing period begins Wednesday, January 18, 2023).
- Write-In Candidate deadline to file for Regular Election Tuesday, February 21, 2023 at 5:00p.m. Please email ASAP any Write-In candidates that filed or let us know that no write-in's filed. (Sec. 144.006, 146.054(b)(2))
 - The Code does not provide direction on how to list multiple write-in candidates for the same office on the List of Declared Write-in Candidates. If there are two or more declared write-in candidates in any one race, the Secretary of State recommends that you list them in alphabetical order or conduct a ballot drawing pursuant to Section 52.094(a) & (c) of the Code.
- Last day for a candidate or write-in to withdraw name from ballot is, Friday, February 24, 2023 at 5:00p.m.
- Candidate ballot drawing position the SOS suggest should be on Monday, February 27, 2023. To have the drawing on Feb. 27th the ballot drawing notice must be posted on or before Thursday, Feb 23, 2023, which is 72 hours before the drawing. (Sec. 52.094(c)) And Sec. 52.094(d) states information on written notice of drawing to each candidate. See SOS Election Law Calendar.

Ballot Proofing

Once you receive a ballot proof from us, you will <u>only have 24 hours to proof</u> and return an approved signature or any corrections that will need to be made. We anticipate sending ballot proofs sometime during <u>March 5th – 6th.</u> Note: Elections office is closed March 2nd.

Election Reporting and Special Reports

- After the election night results are at 100%, no further election results will be posted on the Ellis County Election website till all provisional and late overseas ballots have been counted, hopefully sometime late Friday, May 12, 2023 or Saturday, May 13, 2023.

Canvass Information

Tuesday, May 09, 2023 – First Day to canvass the election if your entity has <u>NO</u> Provisional Ballots, <u>NO</u> Overseas ballots and <u>NO</u> outstanding Ballot by Mail voters that need to correct defects on carrier envelopes. Canvass notice must be posted 72 hours before conducted.

Friday, May 12, 2023 - Last day to receive ballots from certain overseas/late absentee voters (Sec. 101.057; 101.001)

Friday, May 12, 2023 – Last day that a voter can cure their Provisional ballot OR Carrier Envelope at our office (Sec. 65.054(b), 65.0541(a)) Monday, May 15, 2023 - Last day that the Early Ballot Board may convene to qualify/count mail ballots cast (Sec. 87.125(a)) or Provisional ballots cast (Sec. 65.051(a), 1.006). New Law: SB1703 allows the EV ballot board has until the 9th day after the election to qualify and count any provisional or overseas ballots. So pending EV BB schedule, all Military and Provisional ballots will be counted as soon as the Ballot Board delivers them to the Central Counting Station. At that time final unofficial election results will be prepared for canvassing. We anticipate results reports may not be ready till late Friday, May 12, 2023 and we HIGHLY recommend scheduling canvass between May 15-17th. Wednesday, May 17, 2023 – Last Day to canvass the election (Sec. 67.003)

Please refer to SOS Advisory and let the Elections Dept. know of any special deadlines not stated above.

Bond Elections – You will need to refer to the SOS Election Law Calendar and your attorneys for more information about Bond Elections.

2023 Contracted Runoff Joint Election – June 10, 2023 (If required)

NOTE NEW LAW for Ballot Order: The order of the names on the runoff ballot should be in the same relative order as they appeared on the general election ballot, so no ballot drawing is required for the runoff ballot. (H.B. 88, 86th Legislature, 2019)

Friday, June 16, 2023 – Last day that a voter can cure their Provisional ballot OR Carrier Envelope at our office (Secs. 65.054(b), 65.0541(a)) Monday, June 19, 2023 - Last day that the Early Ballot Board may convene to qualify/count ballots cast (Sec. 87.125) or Provisional ballots cast. New Law: SB1703 allows the EV ballot board has until the 9th day after the election to qualify and count any provisional or overseas ballots. So pending EV BB schedule, All Overseas and Provisional ballots will be counted as soon as the Ballot Board delivers them to the Central Counting Station. At that time final unofficial election results will be prepared for canvassing. (Sec.65.051(a), 1.006) We anticipate results reports may not be ready till late Friday, June 16, 2023 and we HIGHLY recommend scheduling canvass between June 19-21th.
