General Information

May participate graduates and students and technics.

Participation in the event "Posters Students' registration is free dental students from all universities in the country and other nationalities who are registered for the congress.

Participation in the event "Posters Professional" registration is free graduates and technicians who are registered for the conference.

Each poster will have an area of 0.90 m x 1.50m

The posters can be assembled the day before meeting and retire at the end of day, in the right place.

Regulation of abstracts. Form and Guidelines

- 1-The body of the abstract must not exceed 250 words, including references, but excluding title and authors
- 2- Abstracts must be written in Espanish / English language. (In this cases one translator will assist the author)
- 3- Abstracts must be typed in single spaced, font should be Times New Roman, font size should be 12, and the font color should be black.
- 4- No tables or illustrations may be included in abstracts.
- 5- Only generic drug names should be used.
- 6- Results and conclusions should be included at the time of submission. If these are missing, the abstract will be rejected.
- 7- The body of the abstracts must contain the following eight sections in this order:
 - **Title:** (Title text should be in bolded font. Capitalize the first word and all proper nouns contained in the title and sub-title. Do not use all capitals. Clearly indicate the nature of the study in the title (i.e.: case-control, randomized controlled trial, etc.).
 - Author(s): (Authors should be listed by last name, followed by first name initials, after the abstract title. The name of the presenting author should be underlined)
 - Affiliations: (Indicate any affiliations to a University/College or Private Practitioners and city)
 - Introduction and Aim of Investigation: (aims/purpose, hypotheses, and goals of the investigation)
 - Material and Methods: (brief description of experimental procedures including statistics, study design and analysis)
 - Results: (findings of statistical analysis)
 - Conclusions: (one or two major conclusions that are supported by results)
 - Acknowledgements and/or Funding Source: (include reference to grant support, (including grant number), and
 disclosure of any financial relationship the author may have with the manufacturer/supplier of any commercial products
 or services)
- 8- Abstracts should be prepared following the below mentioned format:
 - O Abstract for scientific reports. This should include a brief statement of
 - a. the objective of the investigation,
 - b. the experimental methods used,
 - c. the essential results, including data and statistics, and
 - d. the conclusions
 - Abstract for case reports. This should include a brief statement of
 - a. the chief complaint of the patient,
 - b. the main clinical findings
 - c. the diagnosis,
 - d. the therapy plan,
 - e. the outcome of the therapy.
 - O Abstract for literature review. This should include a brief statement of
 - a. the objective of the review,
 - b. the most relevant results,
 - c. the conclusions of the presenter.

The Jury

The Jury that will dictate and designate the winners of each category is made up of five Academic and / or Clinical professionals appointed by the Scientific Committee of the event.

Submission Deadline

All abstracts must be received by **November 10, 2018**. They should be submitted by email to Mrs Rocio Helguera
