- Equity-oriented training workshops (webinars) on evaluation of mobile apps for e-vouchers, and through relevant case studies within performance-based financing
- > Training workshops on systematic reviews and evidence gap map methods through webinars to support the gathering of relevant evidence for systematic reviews and gap maps
- Review of existing frameworks for stakeholder engagement in guideline development in the Americas through consultations with member states to identify barriers, facilitators and conflicts of interest to stakeholder engagement in guideline development
- > Present content of systematic reviews on stakeholder engagement in guideline development through webinars
- > Pilot test, integrate, and disseminate the checklist into guidelines development in the Americas
- > Deliver training modules on novel approaches and mixed methods
- Deliver toolbox for effective advocacy
- Literature review about the uptake and use of norms and standard products by policymakers, managers, and health professionals at practice level in LMICs
