Meeting Minutes

January 26, 2026

Opening:

The Bear Grass Charter School Board met on January 26, 2026, via Google Meet. Delmas Cumbee, Board Chairman, called the meeting to order at 6:00 PM.

Student Enrollment:

Principal Speller provided the headcount by grade for the 2025-2026 academic year.

Total Enrollment	511

Total enrollment is down twelve students since previous meeting. This is due to home schooling, moving to other school districts and one discipline dismissal.

Lottery applications are open and will run through February 13, 2026. Forty-seven applications have been received for sixth grade as well as applications for almost every grade.

Epicenter Update:

- OP-1 North Carolina School Report Cards 2024-2025 academic year
 - Has to be uploaded on school website with official school grade (C) (65)
 - Released by state earlier this month
 - BGCS growth score went from 64 → 78.9; almost a 15 point increase growth
 - Need five points to move to a B
- GOV-3 Conflict of Interest and Nepotism Policy
 - Same policy will be utilized; no legislation has changed

- New playground equipment install is on hold until new classroom has been completed

Tony Hale, IT Manager, updated the board on technology via Principal Speller.

- More printers need to be ordered

Student Services:

- NAEP Testing
 - National Assessment of Education Progress
 - BGCS was selected at random
 - Testing date will be February 17, 2026

 - NAEP staff will bring their own testing supplies
 - The results will be reported through the nation's report card not through the state's report card
- ACT Prep

 - Pizza and Prep for the Juniors
 - March 10, 2026 testing date

Athletics:

Motion to adjourn: Delmas, Second: Charlotte. Motion passed.


