Rally courses will be posted 15 minutes prior to each trial. Move-ups for the trial must be sent to the show coordinator via email or US mail no later than October 14, 2019.

All entries must use the official ASCA Rally entry form with the agreement and must be paid in full at time of entry. Incorrect or missing information (including email address and required signatures) will invalidate entries. Please use one entry form per dog.

All payments will be deposited as they are received. Email confirmation of entries will go out no later than the close of entries on October 1, 2019. Any questions about entries should be directed to the Show Coordinator.

### **Additional Information:**

1. No entry shall be accepted from a dog or handler disqualified from the ASCA Rally program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.
2. Bitches in season are not allowed to compete.
3. The trial will be held indoors in fully matted rings with baby gates. No dogs may be left overnight in the building.
4. Cancellation of entries will be allowed through October 1, 2019; requests must be made via email or US mail to the show coordinator.
5. No entry fees will be refunded after October 1, 2019. Make checks payable to TCASWA and mail to Ann McCabe. Returned checks do not constitute a valid entry. There is a \$35 service charge for returned checks.
6. Move-ups can be made via email or by US mail to the show coordinator no later than October 14, 2019.
7. Entries will be limited to 200 runs total for all classes. A notice will be posted to the ASCA Nationals website and/or Facebook page when the trial is full.
8. Armbands may be picked up during trial check-in on Friday, November 1 from 4-6 pm and from 7:30-8:30 am the day of the trial in the Rally and Obedience Building.
9. Day of Trial entries, if available, will be taken during armband pick-up on Friday, November 1 from 4-6 pm in the Rally and Obedience Building.
10. The age of all dogs will be calculated as of November 1, 2019.
11. No classes will be judged prior to the start times on the schedule, but may be judged later.
12. Please refer to the 2019 ASCA Nationals Premium for directions to the show site, RV rental space, hotel accommodations, local veterinarian services, food vendor information, official show photographer, and other general information.
13. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations. No entry shall be accepted which specifies any conditions as to its acceptance.
14. TCASWA, their Boards of Directors, ASCA, its Board of Directors, and the property owner assume NO RESPONSIBILITY for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children.
