### **NOTICE TO ALL EXHIBITORS**

1. All dogs six (6) months and older must have an individual ASCA registration. Photo copies or originals of papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience/Rally Trials.
2. **Bitches in heat will not be allowed to compete.**
3. No day of show set ups are allowed until 7:00 am Saturday in order to allow for the show committee to set up for the show. Roping off or 'pre-reserving' of day set up spots will not be allowed prior to 7:00am on Saturday
4. The obedience trial will be held indoors in fully matted rings with baby gates. No dogs may be left overnight in the building.
5. Returned checks do not constitute a valid entry and will be charged a \$35 service charge.
6. Move-Ups can be made via email or US mail to the show secretary no later than October 14, 2019.
7. Entries will be limited to 8 hours judging time per judge. A notice will be posted to the ASCA Nationals website and/or Facebook page when the trial is full.
8. Armbands may be picked up during trial check-in on Friday, November 1 from 4-6 pm and from 7:00 – 8:00 am Saturday in the Rally & Obedience Building.
9. The age of all dogs will be calculated as of November 1, 2019
10. No classes will be judged prior to the start times on the schedule, but may be judged later
11. Please refer to the 2019 ASCA Nationals Premium for directions to the show site, RV rental space, hotel accommodations, local veterinarian services, food vendor information, official show photographer and other general information
12. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations. No entry shall be accepted which specifies any conditions as to its acceptance.
13. WASOC, their Board of Directors, ASCA, its Board of Directors, and the property owner assume No Responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children.
