**JR Showmanship:** Pee-Wee (ages 3-5), Sub Junior (ages 6-7), Novice and Open 8-12 & 13-17, and Best Junior Handler.

**Conformation:** ALTERED and INTACT: 6-9, 9-12, 12-15, 15-18, Novice, American Bred, Bred-By Exhibitor, Open Blue Merle, Open Red Merle, Open Black, and Open Red. Classes divided by sex, Winners Dog, Winners Bitch, Best of Breed.

**Awards:** Ribbons 1st through 4th, Rosettes and Awards for BJH, RJH, AWD, ARWD, AWB, ARWB, ABOB, ABOS, ABOW, WD, RWD, WB, RWB, BOB, BOS, and BOW. 10 ALTERED PREMIERS & 20 INTACT PREMIERS WILL BE OFFERED AT JUDGES DISCRETION.

**Pre-Entries ~ Open August 1, 2019 thru September 30, 2019**

All Intact & Altered Classes \$30.00, Junior Showmanship \$10.00

*Entries postmarked prior to the opening date will be returned.*

*Entries postmarked after 9/30 will be charged at onsite rates.*

**On-Site Entries ~ November 7<sup>th</sup>, Time: TBA**

All Intact & Altered Classes \$40.00, Junior Showmanship \$15.00

**Entries will only be accepted for classes that have not met the judge's limit and will be taken on a first-come, first-served basis.**

**GENERAL INFORMATION**

- No entries can or will be accepted for a dog, handler or owner disqualified or not in good standing with ASCA.
- Please use a separate entry form for conformation and juniors. Entry forms can be found at <https://www.asca.org/wp-content/uploads/2016/04/confxentry.pdf>.
- No entry fees will be refunded. Returned checks do not constitute a valid entry. A \$35.00 service fee will be charges for any returned checks for insufficient funds or otherwise.
- **Best of Breed Intact Dog Groups will start prior to the completion of the Intact Class judging.**
- Show schedule and armbands may be picked up Thursday, November 7<sup>th</sup> at the onsite entry table in the Conformation building. Exact location and schedule for pick up: TBA
- Age of all dogs will be calculated as of November 2, 2019. Age of Juniors is calculated as of June 1, 2019.
- No classes will be held with the exception of Bred-By Exhibitor. Exhibitors should be ringside for all classes, ready to be called in. It is the Judge's discretion to allow an exhibitor to enter the ring late. If you have a conflict, please communicate with the ring steward and we will accommodate whenever possible.
- Limited, temporary, ring-side crating will be available, but NO grooming will be allowed in the Conformation Building.
- Any handler, owner, or spectator being abusive towards a dog or exhibiting poor sportsmanship will be asked to leave the show site for the duration of the show without refund of entries.
- WCASA, its officers, members and volunteers assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children. Children are to be supervised at all times.
- Rings will be inside a climate-controlled building. Surface will be mats on concrete.
- For Directions to the site, emergency veterinarian care, hotel and RV information, please refer to the 2019 ASCA National Specialty Premium and or 2019 ASCA National Website. *RV Reservations may need to be extended with the host club if you are not planning to leave the grounds until Sunday morning.*
