What is Return to Breeder Agreement? Every responsible breeder hopes that the homes they send their puppies to are their homes for the duration of their life. Unfortunately, sometimes life events are out of our control. Sometimes things like illness, deployment/moving overseas, divorce, or financial problems lead people to a situation where keeping a dog in their home is not in the dog's best interest. If something like this were to occur, County Line Kennels Mini-Dachs "return to breeder agreement" ensures that the dog's best interest is considered if a change of living situation is needed. We will accept any puppy back that came from County Line Kennels Mini Dachs, *but a refund WILL NOT be given.*

There is a big difference between a Responsible Preservation Breeder and an irresponsible breeder. Sometimes referred to as "backyard breeders", irresponsible breeders breed dogs without much effort in breeding selectively and are generally doing it to make money or simply for the experience of raising puppies. A responsible preservation breeder is someone who is dedicated to contributing to the preservation and improvement of their Miniature Dachshund breed.

Note to Buyers ~

If you need to travel a significant distance to bring your new puppy home and must stop at rest areas or gas stations, County Line Kennels Mini Dachs strongly advises that you **keep your puppy away from ALL pet walk areas**. Once you arrive home, it's also important to stay away from dog parks or any locations where you may find dog feces. This precaution is necessary because your puppy has only received the first of three required puppy vaccinations and is not yet fully protected against Parvovirus. While your puppy has been dewormed four times, they can still easily contract other parasites in these high-traffic areas. It is critical to avoid these places at all costs! Older dogs that appear healthy can still shed Parvovirus, contaminating these environments. Parvovirus is a highly contagious and potentially deadly disease in puppies, especially those between six weeks and six months old. It targets the intestinal cells, leading to severe dehydration and weakness, and there is currently no cure. The virus can remain infectious in the environment for extended periods, typically between five to seven months outdoors. In addition to Parvovirus, other parasites may be present that could affect your puppy even if there are no obvious symptoms. For your puppy's safety, let them relieve themselves only in areas that appear free from signs of other animals.
