It's forecast to be a cold winter in Northern Virginia. Take proper care of your home by winterizing your pipes.


- Disconnect and store garden hoses
- For external faucets with dedicated shutoffs: turn off the shutoffs and drain the water from the faucets
- Turn off and drain sprinkler systems
- Know where your main waterline shutoff is

### SIDEWALK PREP

Sidewalk snow removal is the responsibility of each homeowner/resident. Make sure shovels and snow blowers are ready for the task *before* snow falls.

<u>Tip for sidewalk salt</u>: salt is most effective UNDER the snow. If you're planning to salt your sidewalks, make sure to lay the salt down before the snow falls.
