Extended voting deadline for South Gippsland Council election

"The close of voting for the South Gippsland Shire Council elections has been extended by one week to **6 pm Friday 29 October**, to ensure all voters in the Shire have the opportunity to cast a considered vote.

Electoral Commissioner, Warwick Gately, has requested printers to work through the weekend to reprint a number of ballot packs that have not been delivered. 'Over the past 24 hours the VEC has identified that a number of voters across all 3 South Gippsland Shire Council wards have not yet received their ballot packs for the election. In order to ensure that all voters have adequate time to cast a considered vote and thus ensure the integrity of the election, I have made the decision to extend the close of voting by one week from 6 pm on Friday 22 October to 6 pm on Friday 29 October,' Mr Gately said." Don Hill accused of using South Gippsland Voices to boost council re-election campaign

Reduced reporting during 'Caretaker' Sentinel-Times 19/10/21

DURING the Election Caretaker Period in South Gippsland Shire, likely to be extended to October 30 after voting was extended this week, council is required to ensure that its resources, forums, etc.,

are not used to raise or promote matters that may be considered electoral material. In order to satisfy this requirement, council will not be hearing Administrator Reports at its meeting this Wednesday. Councillors are expected to resume at the **new council's first meeting on November 24**.

Time to start anew, MP says Sentinel-Times 19/10/21

THE Nationals Member for Gippsland South, Danny O'Brien, has the following message – which was read out in Victorian Parliament - for the ratepayers of South Gippsland regarding the shire's election.

"After just over two years of administra-tors in charge, ballot papers are arriving in letterboxes for the election of new council-lors at the Shire of South Gippsland."The election, which is by postal ballot... is a chance for a fresh start after the chaos of the previous council which was dismissed by this Parliament in 2019.

"While I strongly supported that decision, I did so with a heavy heart, as one never wishes to see local democracy curtailed. "Now is the chance for local residents and ratepayers to start anew. "There are some excellent candidates in the three wards, giving good choice to all voters.

"I thank all candidates for stepping forward to take part in local democracy. "It is not my practice to recommend how residents should vote. "But I do hope that people will remember the chaos and dysfunction of the previous council, including those councillors who were only there for a short time but who were also the target of criticism by the Commission of Inquiry, especially over the appointment of a CEO shortly before the council was dismissed.

"We do not need any of the dismissed councillors re-elected. We must put the division, discord and conflict behind us. "I also caution voters to carefully consider the topics candidates are campaigning on or making promises about. "Councils have a clear role to support their communities and provide local infrastructure and services – they should not be distracted on national and international political causes that are beyond their remit. "Vote for candidates who will be focused on roads, rubbish and rates, not those grandstanding on political topics, or seeking to re-write history."

JTSG Responds to Nationals Member for Gippsland South, Danny O'Brien Statement

Local state member Danny O'Brien's recent speech to State Parliament on the current South Gippsland Shire election was an unambiguous attempt to silence the community's voice.

In telling voters they "should not be distracted on national and international causes that are beyond their remit", Mr O'Brien was clearly implying that those in the community who believe local government has a role to play in addressing climate change should not be listened to.

In fact, all levels of government have a role in addressing climate change. Saying that local government should limit itself to roads, rubbish and rates is like saying State governments should just look after schools, hospitals and trams, or that the federal government should focus only on quarantine, vaccination and defence.

Beyond that, Mr O'Brien doesn't seem to realise that the Councillor Code of Conduct in the Local Government Act 2020 specifies in its principles of good governance that:

- The economic, social and environmental sustainability of the municipal district, *including mitigation and planning for climate change risks*, is to be promoted.
- Priority is to be given to achieving the best outcomes for the municipal community, including future generations.

The Act explicitly requires that councils and councillors do exactly what Mr O'Brien tells them not to do.

Many in the community would be interested to hear Mr O'Brien's justification for telling those on the incoming Council that they should ignore the principles laid out for good governance.

Just as interesting would be his motivation for doing so.

We seem to be living in an ever more divided society, with growing narratives of division and blame. And despite Mr O'Brien's claim to be seeking to "put divisions, discord and conflict behind us", his statement does just the opposite.

Dog-whistling about "those grandstanding on political topics", which can be taken to mean climate change, does nothing to promote community cohesion and cooperation and everything to fan the embers of suspicion and antagonism. And what's the point?

Why not instead at least listen to those voices that are, after all, only echoing what every credible authority on the matter of climate change is saying: that we all need to be working together, with empathy and understanding, to move to a low-carbon world that's fairer and inclusive and equipped with solutions for a better, cleaner, brighter future for all now and for those that follow.

As we are on the cusp of the next major meeting of world leaders, at the Glasgow global climate talks to discuss our future, it seems worth noting that the last such meeting - the Paris Climate Agreement - recognised the importance of authorities at the local and municipal level as key drivers in strengthening local resilience to climate change.

The Paris Climate Agreement notes that "regions may be powerhouses of ambitious mitigation and adaptation measures that are hard to legislate and implement at the national level."

Rather than trying to undermine the many voices in the community who are concerned about climate change, why not listen to what they're saying and lead the way with the people you say you represent.

Mr O'Brien should recognise that people all over the country are forming and joining groups like Just Transition South Gippsland because they're feeling frustrated and helpless about the lack of action, the lack of leadership and the stark failure of politicians and institutions to engage honestly with the question of how we build a safe and just future.

Their concerns about the future of the region and its people are reasonable and sensible. Danny O'Brien shouldn't be fighting against them; he should be joining them.

Australia's decision not to boost its 2030 emissions reduction target will disappoint key allies that have called on Prime Minister Scott Morrison to do more ahead of next month's United Nations climate summit in Glasgow....

Liberal-aligned think tank Blueprint Institute, which surveyed voters in resources seats over the past two weeks, found 67 percent of respondents in Capricornia and 68 percent in Flynn – both central Queensland electorates – backed a halving of Australia's emissions by 2030. In the NSW seat of Hunter, 74 percent were in support **along with 76 percent in Gippsland, Victoria.** (more available)


Who will use the chargers? Sentinel-Times 19/10/21
