David Faust seconded, and the motion carried 2-0.
  - David Faust moved to approve payment to Jesse Shutt for \$1,000 contingent upon a successful grant application submission. Charlie Bisking seconded, and the motion carried 2-0.

A. Deitrich Road Speed Limit Sign Request – An email from a concerned citizen was reviewed regarding additional speed limit signage on Deitrich Road. The citizen indicated that traffic moves at excessive speed and she feels unsafe walking her dog in that area. The Board of Supervisors is looking into her concerns and will check for Ordinances pertaining to the situation and signage.
