January 6, 2020

CALL TO ORDER: Chairman Hoover called the meeting to order at 7:30.

ROLL CALL: Present: Chairman, Justin Hoover; Vice-Chairman, Jason Graff; Supervisor Charles Bisking; Secretary/Treasurer, Robyn Loesch; EMC, Don Shutt; Roadmaster, Rick Grosser. Three citizens also attended this meeting.

APPROVAL OF MINUTES:

Supervisor Graff made a motion to approve the minutes of the December 4, 2019 Regular Meeting. Seconded by Supervisor Bisking and all were in favor. Motion carried 3-0.

TREASURER REPORT:

The Treasurer reported that the General Fund bills totaled \$7,095.82 and Wages were \$2,510.78. As of January 6, 2020, after payment of these bills and wages, the General Account balance will be \$7,269.63, Reserve Account \$990,518.04 and State Liquid Fuels account balance will be \$254,215.56. There are also seven new current bills totaling \$7,363.97.

Supervisor Graff made a motion to pay all of the bills and wages; and to also pay the seven recent bills. Seconded by Supervisor Bisking and all in favor, and motion passed 3-0.
