A Local Law granting no exemption from taxes for Solar, Wind, or other means of energy development.

WHEREAS, Section 487 of the New York State Real Property Tax Law provides that a Town may adopt a local law to provide that no exemption be granted under section 487 of the Real Property Tax Law to any solar, wind energy system, farm waste energy system or other energy development systems, and

WHEREAS, it is in the best interest of the Town of warren to adopt such a local law;

NOW, THEREFORE, the Town of Warren does hereby adopt Local Law # 1 of 2016 to provide that pursuant to Section 487 (8) of the New York State Real Property Tax Law, no exemption shall be granted under Section 487 of the New York State Real property Tax Law with respect to any solar, wind energy system, farm waste energy system or other energy development systems in the Town of Warren, Herkimer County, New York.

This local law shall take effect upon the filing with the New York State Department of *State*
