Hwy. Supt. Aney told the Board that the Town Barn roof is still leaking and he has repeatedly tried to contact the contractor but is getting no results or answers or return of his phone calls. The bard told him to contact Hyde Clark about pursuing this matter further.

Hwy. Supt. Aney has placed several surplus items up for auction on Auctions International. He has received bids and the auction is due to close very soon. (See copy of these items attached.)
Motion to accept the bids on these items was made by J. Crockett and second by R. Vaughn.

Mr. Aney also told the Board of a minor dispute over some damage to a gate owned by Alan Mang with snow being pushed into the gate. The Highway crew measured the distance from the center of the road and the gate. It seems the gate is right on the line. The Board will not replace the gate.
