Highway Supt. Glenn Armstrong told the Board that the Monetary is unhappy about the wind tower planned in the Town of Stark is visible from their property and have contacted the Historical Society of NYS about it.

Mr. Armstrong also informed the Board that the Planning Board has received a request to erect a cell tower on Mary Hill Road. Mr. Armstrong does not have information about prices for this. Town Clerk has paperwork concerning this matter and Mr. Armstrong will get it from her.

The matter of Mason Road was discussed. Mr. Gilbert told the Town Clerk that he and his family has decided that they are not willing, as previously agreed, to pay for the repairs to Mason Road. Mr. Gilbert requested 2 or 3 more estimates for the repair work other than Suit-Kote,s estimate. Highway Supt. Aney told the Board that Suit-Kote has don the work on Mason Road last year and it was Chips Program project. Mr. Aney also told the Board that Suit-Kote has their equipment and crews in the area and the cost would for them should be more reasonable because of this.

The Board also feels that if Mr. Gilbert wants additional quotes that it is his responsibility to get them.

Supervisor Crockett will send Mr. Gilbert a letter explaining this and why the Town cannot repair this road for 10 years. (Chips Program)
