Sublette BOCES has a far-reaching grant-in-aid program available to K-12 students residing in the Sublette School District #1. Our grants are meant for students who wish to engage in forms of educational enrichment, such as sponsored trips with an educational purpose, higher education experiences, and academic competitions. Sublette BOCES will pay up to \$250 per student, and up to \$2,500 to groups of students of ten or more who apply for a grant. Groups are led by an adult or sponsor and defined by all attending the same educational experience. In the case of group applications, the amount awarded will not exceed \$500 per student. Grant-In-Aid awards are limited to \$250 per student each fiscal year. BOCES will not pay for a repeat experience in the same fiscal year.

While the maximum paid for a grant-in-aid is \$250, applicants are expected to pay a significant portion of the total cost of the trip or program. Grant funds to the requestor will be processed once a reimbursement request is received by BOCES with accompanying receipts showing expenses of the cost of the trip or program. In extraordinary circumstances, a grant-in-aid may be awarded for more than \$250 if one or more of the following are demonstrated.

1. Extraordinary financial need
2. Exceptional enrichment experience is available
3. Unusual circumstances arise that present unique obstacles to the ability to engage in a valued enrichment experience

To be awarded funding, each applicant must submit an application and then attend a regular meeting of the Board to seek approval of the request. The applicant should also prepare to report back to Sublette BOCES on their enrichment experiences.

- Students making a request must also appear in person at the board meeting to make their request and answer any questions.
- The board will make a decision on funding at the following regularly scheduled board meeting.
- Funding will be released once receipts , or confirmation of attendance are submitted for the expense.
