Every effort has been made by SANDLOT REVOLUTION @ THE MEANTIME to ensure that safety is a top priority, and that proper safety techniques are practiced and enforced by all members and agents of SANDLOT REVOLUTION @ THE MEANTIME. For the safety of all parties participating in services at SANDLOT REVOLUTION @ THE MEANTIME, please read the terms detailed below, and complete all fields below and provide a signature confirming your understanding and agreement to all terms herein.

- 1. Visitors under the age of 18 must have a parent or legal guardian complete any required registration documents and this liability release form before the student or customer will be allowed to participate in activities on the premises.**
- 2. Participation in the use of any of the equipment on the premises is solely at the risk and liability of the student/customer (or parent/legal guardian if under the age of 18).**
- 3. As stated above, every effort will be made by SANDLOT REVOLUTION @ THE MEANTIME and its agents to ensure safe use of all equipment by visitors, but due to the potentially dangerous nature of baseball hitting equipment and tools, SANDLOT REVOLUTION @ THE MEANTIME will not accept liability for any injury or damages that the students or customers may suffer related to the premises of SANDLOT REVOLUTION @ THE MEANTIME, or activities sponsored by SANDLOT REVOLUTION @ THE MEANTIME.**
- 4. In the case of injury, any cost incurred from the emergency medical treatment or medical transportation to a local hospital will solely be the responsibility of the student/customer (or parent/legal guardian if under the age of 18).**
- 5. Any personal belongings of the student/customer or the legal guardian that enter the premises of SANDLOT REVOLUTION @ THE MEANTIME remain the sole responsibility of the student/customer or legal guardian. SANDLOT REVOLUTION @ THE MEANTIME shall not be responsible for lost, stolen, or damaged property or belongings.**
