A LETTER FROM THE EXECUTIVE DIRECTOR

Dear LIHCA Membership,

Over the last quarter, LIHCA members and our staff have worked diligently on several major initiatives to advance housing and homelessness justice in Alabama. I am excited to share some of this work with you.

First, we are extremely excited for the upcoming Southern Conference on Homeless and Housing, October 26-28, 2022 in Sandestin, Florida. This year, we are proud to have national keynote speakers, Ann Oliva, Executive Director of National Alliance to End Homelessness; Diane Yentel, Executive Director of the National Low-Income Housing Coalition; and Jeff Olivet, Executive Director of the United States Interagency Council on Homelessness, presenting on the best practices and most innovative plans. In addition, the conference will include sessions from practitioners, advocates, and other stakeholders across the Southeast on innovative and emerging practices to end homelessness and advance affordable housing. A very special thanks to our Program Committee, staff, and sponsors for the hard work and support to make LIHCA's annual conference a meaningful time together. Fast approaching is the 2023 Alabama Legislative Session. During this session, LIHCA will continue to advocate for an investment into the Alabama Housing Trust Fund (AHTF). With billions of American Rescue Plan Act (ARPA) dollars yet to be spent, we and our policy partners are calling for a \$25 Million investment to the AHTF. Building on our momentum from our June 3, 2022, AHTF Roundtable discussion with elected officials, we continue to expand our policy partner network throughout the state by working with developers, housing providers, banks, ADECA, AHFA, and those with lived experience to build a campaign backed by research to advance the funding of the AHTF. We plan to fully launch this campaign later this Fall. I call on everyone to be a part of this campaign to ensure we seize this opportunity to fund the AHTF thus increasing affordable housing for Alabamians in the greatest financial need.

I would be remiss not to thank all those who have supported and invested in our work this year. A special thanks to this year's sponsors; Regions Bank, Federal Reserve Bank of Atlanta, Cadence Bank, Truist Bank, Trustmark, Enterprise, Fahe, United Bank, Alabama Habitat for Humanity, Fred Bennett Group, and Neighborhood Concepts. We have also received grants from The National Low Income Housing Coalition, Community Foundation of Greater Birmingham, and Southern Partners Fund. Ann Oliva, appointed earlier this year as Chief Executive Officer of the National Alliance to End Homelessness (NAEH), will ground the conference by highlighting emerging practices in the meaningful engagement of those with lived expertise of homelessness and advancing initiatives promoting racial equity in housing services. Following Ms. Oliva's presentation, attendees will have the opportunity to ask questions and engage with her and other NAEH staff.

Ann Oliva is the CEO of the National Alliance to End Homelessness, a public education, advocacy, and capacity-building organization dedicated to ending homelessness in the United States.

Ms. Oliva previously served as Vice President for Housing Policy for the Center on Budget and Policy Priorities and as a Senior Policy Advisor at the Corporation for Supportive Housing. Her distinguished career is also marked by a decade of federal service at the U.S. Department of Housing and Urban Development (HUD). In 2015, Ms. Oliva was named one of the 50 Most Influential Leaders in the department's first 50 years and was honored with the True Colors Fund's True Leader Award.

Session Title: The Reality and Disconnect Between Affordable Housing and Incomes

Session Description: This session is intended to point out the reality between housing affordability and the income levels of persons seeking housing. The session is also intended to start a conversation about the disconnect between housing affordability, the income necessary for an individual to access housing, and the availability of affordable housing. Housing costs are rising all over the country, particularly rents. This phenomenon has caused a crisis in housing that needs to be addressed. In addition to the lack of affordable housing and housing affordability, a corresponding issue is a rise in evictions across the country. These issues need to be addressed concurrently.

Session Title: Strategies in Self-Leadership: Investing in Yourself to be the BEST Leader you can be.

Session Description: While rewarding, working with affordable housing, health, and social services can be very demanding on time, energy, and resources. In addition to these challenges, COVID and other contextual issues have challenged leaders to find time for reflection and learning as they tend to crises and sustainability issues. This workshop will focus on what it means for a leader to be trauma-informed and carve out the space needed to care for themselves during challenging times. This interactive session will begin with a discussion on understanding key self-leadership strategies and their connection to improved organizational capacity. We will then identify and use self-leadership tools to enhance practice. Participants will have an opportunity to apply in a small group. Last, we will reconvene as a large group to better understand the utility of self-compassion, vulnerability, and reflective practice.

Session Title: VAWA Housing Protections: What You Need To Know

Session Description: This session will explore the contextual history of protections offered to survivors under the Violence Against Women Act (VAWA) and how housing protections have evolved and expanded over time. The session will open with a discussion exploring knowledge and current practices among communities represented in the audience to support survivors' housing stability and safety. From there, the presentation component will review pertinent background information regarding VAWA and its reauthorizations. The session continues by reviewing the populations and housing programs covered under VAWA housing protections. We will then go through the specifics of VAWA housing protections and the responsibilities of housing providers. Finally, we will explore some examples of how communities have designed emergency transfer plans, and audience members will be asked to identify and share the next steps for their communities and/or successes they have seen in implementing VAWA housing protections.

Session Description: Fahe has launched an initiative to increase homeownership opportunities for those who have had limited access or have historically been left out of affordable homeownership programs. Fahe will offer training, technical assistance, and resources related to the USDA 502 Direct Loan Program to address racial inequity. This initiative aims to increase access to 502 Direct loans for communities and households of color through the local capacity created as USDA 502 Direct Loan Application Certified Packagers. USDA's 502 Direct Loan Program assists low-income homebuyers in eligible rural areas by providing payment assistance to increase a qualified applicant's borrowing capacity. Payment assistance is a form of subsidy based on an annual income review, reducing a borrower's mortgage payment to allow greater affordability and borrowing power.

Session Description: This presentation will discuss why CoCs must consider IPSV when addressing community homelessness. Participants will learn how House of Ruth Maryland engaged their local CoC to elevate awareness of IPSV as a contributor to and a result of homelessness and successfully partnered with the CoC to provide services to this vulnerable population while fully protecting survivor safety and confidentiality. Included will be a description of how HRM leveraged both victim services and homelessness policies and funding streams to institutionalize local IPSV survivor access to housing services, including funding a parallel victim coordinated entry system, establishing a highly successful rapid re-housing program, Safe Homes Strong Communities, and accessing COVID 19 emergency funds to support survivors through the pandemic. Results from the recently completed NIJ study examining the effectiveness of this housing model will be shared. Through large group and small group interaction, attendees will have a chance to practice identifying partnership opportunities within their local area, and walk away with concrete strategies to create or enhance partnerships and systems to better serve individuals experiencing both IPSV and homelessness.

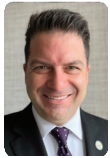
Session Description: Addressing the homelessness and housing crises in the South requires a collaborative, multi-system approach. Assembling the pieces of the housing puzzle simply is not enough. We must place them strategically and focus on proven approaches rather than reinventing the wheel. Diane Yentel, President and CEO of the National Low Income Housing Coalition, and Jeff Olivet, Executive Director of the United States Interagency Council on Homelessness, lead the country in collaboration with partners from across systems to find solutions for people experiencing homelessness and who are unstably housed. Southern Conference attendees will hear strategies, plans, and best practices for solving the homelessness and housing crises in the South from leaders in the field. Attendees will walk away with increased knowledge of strategic collaboration happening across the country and hope for advancing equity in the field during the upcoming years.

Diane Yentel, President and CEO of the National Low Income Housing Coalition

Diane Yentel is the President and CEO of the National Low Income Housing Coalition, a membership organization dedicated to achieving racially and socially equitable public policy that ensures people with the lowest incomes have quality homes that are accessible and affordable in communities of their choice. With over twenty-five years of experience working on affordable housing, Diane is a leading national expert on housing insecurity and homelessness. Under her leadership, NLIHC has deepened, broadened, and strengthened the movement for housing justice, leading major national campaigns to achieve historic federal protections and investments for low-income renters and people experiencing homelessness during the pandemic. In her role, Diane works closely with members of Congress, the White House, numerous federal agencies, and partners and allies throughout the country. Diane is frequently called upon to testify before Congress and to provide commentary to major media outlets.



Jeff Olivet, Executive Director of the United States Interagency Council on Homelessness

Jeff Olivet is the Executive Director of The U.S. Interagency Council on Homelessness (USICH). USICH is the only federal agency with a sole mission to prevent and end homelessness in America. USICH works across federal, state, and local governments and the private sector to help communities create partnerships, use resources efficiently and effectively, and employ evidence-based best practices. Mr. Olivet has worked extensively in homelessness and housing, health and behavioral health, HIV, education, and organizational development throughout his career. Jeff has been the principal investigator on multiple research studies funded by private foundations and the National Institutes of Health. USICH believes housing should be a right—not a privilege, guided by the following values: Racial Equity, Housing First, Decriminalization, and Inclusion.
