The parties, Voices of Our Youth and
(Volunteer), enter into this Volunteer Agreement & Full Release effective this day of
, 20 wherein, in exchange for the opportunity to volunteer at Voices
of Our Youth , by initialing in the lines below the Volunteer agrees to the following terms and conditions:
Volunteer agrees that s/he is volunteering solely for personal, civil, charitable or humanitarian purposes without promise or expectation of compensation, benefits or future employment from Voices of Our Youth
Volunteer will perform services under the direction and control of the <i>Voices of Our Youth</i> staff.
Volunteer will assist with the following assignments such as baby-sitting, various administrative tasks, cleaning, event assistance (including but not limited to: set-up, clean-up, lifting up to 40lbs if capable, food prep, and activities assistance), and workshop / class instruction.
Volunteer acknowledges that s/he is not an employee of Voices of Our Youth and is not entitled to receive salary, benefits or other compensation. Volunteer further acknowledges 100% of al funds raised by him/her while volunteering for Voices of Our Youth will go to Voices of Our Youth as a nonprofit organization.
Volunteer understands that s/he does not qualify for worker's compensation benefits, and is expected to carry personal medical insurance to cover medical expenses for any injury s/he may incur while performing services voluntarily for <i>Voices of Our Youth</i> .
If Volunteer is not a citizen or permanent resident of the United States, Volunteer certifies that s/he has appropriate visa status that authorizes Volunteer to be present in the United States and allows Volunteer to participate in the volunteer experience.
The parties agree that this is the entire Agreement between them and that no Agreement, either oral or written, exists outside this Agreement regarding the volunteer services described in the Agreement.
