THIRD AMENDMENT TO THE DECLARATION FOR SAND LAKE COVE

FOURTH AMENDMENT TO THE DECLARATION FOR SAND LAKE COVE

Article IX, Section 1 of the Declaration for Sand Lake Cove shall hereby be amended to read:

Section 1. Architectural Control Committee. No building, fence, including chain link fences, wall or other structure shall be commenced, erected or maintained upon the Community, nor shall any exterior addition or change or alteration therein, including a change of the building exterior paint color, be made within the Community until the plans and specifications showing the nature, kind, shape, height, materials and location of the same shall have been submitted to and approved in writing as to the harmony of external design and location in relation to the surrounding structures and topography by the Board, or by an architectural control committee composed of three (3) or more representatives appointed by the Board ("Committee"). In the event said Board or its designated Committee fails to approve or disapprove such design and location within thirty (30) days after said plan and specifications have been submitted to it, approval will not be required and this Article will be deemed to have been fully complied with. Nothing contained herein shall relieve the Owner from the responsibility of obtaining proper governmental approvals and permits.

Members shall submit plans to the property management agent for Sand Lake Cove using the approved Sand Lake Cove Architectural Application form. The property management agent shall date stamp all plans upon receipt. The submission period shall commence from the receipt stamp date.
