“ORDINANCE AMENDING SEWER RATES CHARGED TO USERS OF THE WATERWORKS SYSTEM”

WHEREAS, the Village Board of the Village of Galatia has previously set and periodically amended the rates charged to users of the Waterworks System:

WHEREAS the Village Board of the Village of Galatia deems it necessary to amend the rates charged to users of the Waterworks System including users inside of the Village.

THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF GALATIA, SALINE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION I

All sections of said prior Ordinances establishing the rates charged to users of the Waterworks System are deemed repealed as of the effective date of any other sections of said Ordinances.

SECTION II RATES FOR SEWER SERVICE TO USERS IN THE VILLAGE

All users within the Village shall be charged the following rates for sewer usage:

FIRST	2,000 gallons per month	\$12.13 (minimum)
NEXT	8,000 gallons per month	\$ 5.63 per 1000
NEXT	40,000 gallons per month	\$ 2.13 per 1000

SECTION III EFFECTIVE DATES OF RATES

All rates listed in Section II shall be paid by customers on all bills sent to customers on or after June 1, 2023.

SECTION IV

When this Ordinance becomes effective, a copy of thereof, properly certified by the Village Clerk, shall be filed in the Office of the Recorder of Deeds of Saline County,

Illinois, and shall be notice to all owners of real estate of their liability for water and sewer service supplied to an occupant or user of said services on their property.

The Village Clerk is hereby authorized and directed to file sworn statements showing such delinquencies in the Office of the Recorder of Deeds of Saline County, Illinois, and the filing of such statements shall be deemed notice of the lien of such charges for such services.

SECTION V

- A. All prior ordinances of parts of ordinances in conflict herewith are hereby repealed.
- B. The invalidity of any section, clause, sentence, or provision of this Ordinance shall not affect the validity of any other part of this ordinance which can be given effect without such invalid parts or parts.


SECTION VII

This Ordinance shall be in full force and effect from and after its passage, approval and publication according to the laws of the State of Illinois on the 8th day of May 2023.


