DOCUMENT FOR IMIGRATION : A ONLY PASSPORT ACCEPTED FOR VESSEL CALL AT SAMARINDA PORT AND VALID MORE THAN 6 MONTH.

IF PASSPORT VALID LESS THAN 6 MONTH IMIGRATION OFFICER WILL GIVE PINALTY EACH PASSPORT.

B. SEAMAN BOOK WILL NOT ACCEPTED AND IMIGRATION OFFICER WILL NOT STAMP ARRIVAL AND DEPARTURE AT SEAMAN BOOK AND FOR THE CREWS ONLY EQUIP WITH SEAMAN BOOK THE IMIGRATION OFFICER WILL NOT ALLOW TO GO A SHORE

DOCUMENT EXPORT PERMIT : 1. SHIPPER SHOULD BE SUBMITT EXPORT PERMITT (PEB) BEFORE VSL ARRIVAL OR BEFORE COMMENCE LOADING

2. IF VESSEL COMMENCE LOADING AND SHIPPER NOT YET FINISH PROCESS (PEB) CUSTOMS WILL GIVE PINALTY TO SHIPPER & VESSEL (AGENT)

3. CUSTOMS WILL ARRIVAL FOR CHECKING EACH VESSEL ON DAY LIGHT AND BEFORE CUSTOMS COME ON BOARD VESSEL CAN NOT COMMENCE LOADING

CAN NOT COMMENCE COADING.

4. BEFORE VESSEL COMPLETE LOADING, THE AGENT SHOULD BE PROCEES OUTWARD MANIFEST TO SMD CUSTOMS WITH INSERT SHIPPER (PEB) CODE NUMBER TO OUTWARD MANIFEST, CUSTOMS WILL GIVE PINALTY IF AGENT LATE TO PROCESS OUTWARD.

7. IF VESSEL DO MAKE DRAFT SURVEY EACH SHIPPER ON BOARD , AGENT SUBMITT MANIFEST USE DRAFT SURVEY ON BOARD
