'92 Objectives

Quarterly Membership Meetings Change Proposed

Quarterly Membership Meetings in January, April, July and October with the October meeting considered the Annual Meeting when new Directors are elected. For the past two years, these meetings have been held at 10 A.M. on the second Saturday of the month. Before that, they had been held at 7 or 7:30 P.M. Fridays but were changed to Saturdays when some members who lived out of town said they could not get here in time for a Friday evening meeting but could for a Saturday morning

Attendance on either Fridays or Saturdays has been marginal usually running somewhere between 15 and 30 attendees. When asked why they do not regularly attend them, many people tell us it is not OK and they don't see any need to be there.

In assessing this situation, the Board of Directors has decided to put to a vote at the January 11 meeting a suggestion that we reduce the number of membership meetings a year from 4 to 2...one in April and one in October. The Board will not make a decision on this until late January in order to give our readers an opportunity to send in their suggestions.

Unfortunately, many people are under the impression the pathways running along both North and South Forest Beach Drives are for the exclusive use of bicyclist. This is not the case at all. They are there for the use and enjoyment of walkers, joggers, people pushing baby carriages and other legitimate uses of sidewalks in other sections of the country. Their primary purpose is to keep people off the streets and thus avoid potential accidents.

A member recently submitted the following common sense ideas people using these pathways should follow for the safety and

pleasure of everyone:

 Stop and look both ways before crossing any street intersection.

If you are walking or riding two or more abreast, give way to oncoming traffic by pulling to the right side of the pathway.

If approaching people from behind, give warning of your approach rather than scaring them half to death. Use a bell on your bike or call out "Hello, coming through please".

Ride at a reasonable speed these are not racetracks.

Anticipate in advance what you will do when you see someone coming from the opposite direction.

6. Above all, be as courteous to the other fellow as you would like

him to be to you.

The following are some of the points covered in a report by the Special Services staff to the Town Council regarding the operation of this facility in 1991.

• There was a significant increase in

patronage.

 The majority of patrons were families, church groups and civic groups.

A minimal amount of boisterous

and rowdy behavior.

- Most people felt the beach park provided a safe, clean area for people of all ages to enjoy the beach.
- The parking lot averaged 112 cars a day vs 64 cars a day in 1990.
- Parking lot revenues increased to \$54,783. from \$37,877. in 1990.
- Parking meters produced \$30,984.
 vs \$18,499. in 1990.
- 95 residential parking permits were sold vs 18 in 1990.
- 162 annual passes were sold vs 17 in 1990.
- 86 vehicles were towed from the Forest Beach area most of which were parked in the beach accesses or in "No Parking" areas.

The Town's Special Services staff, who operate the park, feel the 1991 operation showed a big improvement over 1990 in all phases of the beach park operation including policing of the "No Parking" signs.

We agree with their assessment and thank them and Town Council for this well managed and maintained facility which has had a positive effect on the image of the area. Beach Access Inventory

As outlined in the October 1991 Newsletter and discussed at the October 12th Quarterly Membership Meeting, Directors Jackson and Paris completed a thorough inventory of each of the beach access points in the Forest Beach area and assessed their condition.

While all the beach access points throughout the area were reviewed, greater attention was given to those where the access to the beach is impeded by the rock revetment. The Board felt its first priority should be to make access reasonably easy and safe over the revetment and to then improve the existing access points both from a safety and appearance standpoint.

After their review, the Board set the following priorities for improv-

ing access points:

1. Build a walkway over the revetment at Pelican Street where none presently exists.

 Build walkways over the revetment at Kingfisher and Lark Streets where none presently exist

 From both a safety of use and appearance standpoint, improve the existing walkways over the revetment at Ibis and Sandpiper Streets.

While there is considerable work to be done to draw up appropriate specifications, getting bids and examining them, etc., it is hoped work can start by late winter/early spring on what we can afford to have done.

Beach Sweep

In late September, a state wide effort to clean up debris on the beaches and river banks throughout the state was undertaken with many local residents participating. In South Carolina, this effort is coordinated by the Sea Grant Consortium, Water Resources Commission and other state agencies concerned with the environment.

Our Association was asked to sponsor teams of individuals who would be responsible for picking up debris in specified sections of the beach in the Forest Beach areas. Unfortunately, this invitation came too late for us to organize teams but many residents participated in the project on an individual basis.

The sponsors expect to conduct a Beach Sweep twice a year—once in the spring and once in the fall. Since the beach is such an important feature of our area, we

would like to sponsor a number of teams which would be responsible for sections of the beach in our area. The effort is really quite easy. What you do is walk along the part of the beach assigned to your team and pick up debris—cans, plastic packaging materials, broken glass, cigarette butts, etc.—put it in plastic bags that are supplied for the purpose and turn them in at a central point. The time it takes runs from 1 to 3 hours depending on the number of volunteers and the amount of time they will help.



1992 Dues

Despite the fact Association expenses have increased in the past year—primarily due to legal fees involved in attempting to resolve the transfer of assets and in covenants enforcement—the Board voted to maintain them at the same rate as they were in 1991, which was:

Dues notices, in accordance with the above schedule, will be sent out in early January. Your prompt payment

of them will be greatly appreciated as the cupboard is quite bare.

After the manner in which the transfer of assets has been resolved, the Board will review the cost of operating the Association and how those costs can be covered in a way that is fair to all property owners in the area. Until this has been resolved, the Board can only guess at what its annual costs will be. This is the main reason why any decision regarding the installation of an Annual Community Improvement Assessment has been postponed until after the transfer of assets is finalized.

Your House Address

Do you have your proper address posted on your property for identification in case of an emergency so the Fire Department, Rescue Squad or Sheriff's Department personnel can find it quickly? If you do not know your official address, please call the Town of Hilton Head Island at 681-8396 — they have it. Please remember, your lot number is not your legal address.

The Town Code provides:

Section 603.17.1: Lettering is to be not less than three (3) inches in height and one-half (1/2) inch in width and

plainly visible.

Section 603.17.2: All newly dedicated streets shall be provided with street identification signs by the developer and approved by the Town Manager or his designee.

Beach Pass Cost Reduced

At its meeting immediately prior to the November 5th elections, the Town Council voted to reduce the cost of

a beach pass from \$30. in 1991 to \$10. in 1992.

This is the pass residents can purchase from the Town and be allowed unlimited parking in any of the Town's beach parking lots (Coligny, Folly Field, Burke's Beach) and in the parking meter spaces at those locations. Such a modest fee should encourage all residents who go to the beach only occassionally to get a decal from the Town and not have to take a chance of parking illegally when they do go to one of the Town's beach parks.
