Covenant Enforcement Report

- Forest Beach Villas FBOA cannot become involved in their lawsuit. Russell Paterson responded to their inquiry.
- 20 Heron Street there were some covenant questions from an owner who originally purchased his property 50 years ago from the Hilton Head Company.
- Lot 7 (central Forest Beach) is a commercial lot for beach parking. There is no residential construction allowed there. There was an LMO committee conversation concerning ordinance changes in the resort district. The present ordinance includes a construction height limit of 30 feet, 30 feet from Pope Avenue and 70 feet from the property line in the rear.

Unfinished Business

- The paving on Pope Avenue is finished, although not wonderful. The traffic light at Lagoon Road and Pope Avenue goes live tomorrow, December 10. Bathrooms and extra parking spots are to be completed by March 15 for the St. Patrick's Day parade.
- Community Foundation We are still waiting to hear from attorneys concerning the establishment of a 501c3.
- Fall newsletter Everything must be turned in to Coastal Marketing by December 17. Asking for suggestions elicited a mention of the history of Forest Beach and its subdivisions breakdown.
- There will be a conversation about a dues increase for next year in the March BOD meeting.

New Business

- Goals from the 2019 retreat have we achieved them? Many of the goals are ongoing. We will revisit them in January 2020.
- The annual meeting of the membership will take place on October 17, 2020.

Comments from members

- The tomato seller was given a permit by the Town for in-season sales. We will talk to Teri Lewis about roadside solicitation.
