Minutes: The minutes were approved as read.

Financial Report: Submitted is the year end statement and the January report. Dues receipts are lower than in January last year. The post office lost our mail for a week, which may account for this. PayPal payments have increased a little over last year. The report was approved as submitted.

Committee Reports

- Update from BCOLT after the annual walkthrough (11/15/23) FBOA received a brief response, stating that we are in compliance and showing a GPS map of this year vs last. There are still a few encroachments, which we are working on. The letter thanked us for our efforts.
- Tier 1 (adverse possession issues) we are still working on these
- Tier 2 (gray water dumping in the dunes) we are still working on these
- 10 Bayberry Ln mowing the dunes we are still working on this
- 6 Sea Oak tree topping, brush clearing we have attempted to serve the owner in WV, now the attempt is being made locally
- 9 Juniper tree topping, brush clearing FBOA is waiting on the town's decision. The owner has an attorney who is trying to resolved this without litigation. They have filmed other properties through drone footage, claiming that others have done this and we are picking on them. FBOA wants mitigation.
- LMO Overlay Committees
 - Beach Committee Sea Turtle Patrol has created a new assistant group, The Sea Turtle Patrol Auxiliary, to work with them in lieu of Turtle Trackers. There has been friction between the two groups. Turtle Trackers will continue to exist, but Debbie has resigned from the organization to join the Auxiliary. Everyone involved makes their own decision. This is still evolving, so more information next month.

There has been some hoopla about how the town awards contracts to businesses who service the beach: chairs, umbrellas, life guards, trash collection, etc. Some businesses who want a stake in the contracts would like to see the town separate services instead of issuing one contract that covers all services. FBOA doesn't have a stake in which vendor is awarded a contract, but we will voice our strong opinion that the beach not become commercialized (e.g. hot dog carts, catered picnics). Debbie will draft a statement to the town to be sent out to the board members for approval.

- 2. Forest Committee Tim Evans, commissioner of the forest for the SC Audubon Society walked our forest with Amy and Jack. Audubon has more qualified people on staff than BCOLT does. Some suggestions and comments included: 1) certain species of birds and other creatures cannot survive anywhere else, 2) mark the corner where the oceanfront lot meets the strand, and that's where you place the signs and QR codes, 3) place signs also where the strand meets the street. We need an updated survey to identify the shoreline forest and reflag the points. Larry will research who did the original survey and inquire what the additional cost would be to update it. FBOA will then immediately install the posts with rebar; Chuck Perry is still interested in doing that part of the job. Pictures will be taken following the installation. Amy has spoken with Kate Renault, president of the HHI Audubon Society and she is starting a bird friendly certification program, of which we can be a part.
- 3. Beach Parking Jack and several business owners in Coligny Plaza met with Josh Gruber in January. The town committee is considering the points we brought up, and the February meeting has been pushed back to March. The later in the year this is discussed means that the paid parking may not be implemented this season.
- 4. Golf carts in FB nothing new
- 5. LMO changes related to parking requirements and square footage for short term rentals this is also tabled with town staff. Staff is trying to dictate parking spaces based on the square footage of the house. Square footage under 3000 sq ft was not addressed. No maximum number of spaces was stated, but the spaces would be required to be impervious. All of this is confusing and problematic. Staff will redo the numbers to make all of this easier to understand. Staff is also trying to take this parking issue out of the LMO and put it into the STR ordinance. We must keep our eyes on this issue also.
- 6. Safety committee there was another monthly meeting; Bob Bromage was not present. Massimo had a sidebar meeting with Karla Vincent; she has adopted the project of bike paths and crosswalks. The town is going to focus first on the bike paths on Palmetto Bay Road and Arrow Road, as they are county funded. Kiosks and rest areas will be installed along the paths. There are crosswalks that will be remarked at several locations. Email her with any suggestions. The monthly bike meeting at the Chamber is at 10:00 am every 3rd Wednesday in the board room. Anyone can attend. Bike paths on the ocean side of South Forest Beach Drive and along Lagoon Road to Ibis Street are on the town's

radar, but refurbishing the existing paths is first. Darren Schumacher is working on pedestrian crosswalks.

Massimo will ask Bob Bromage if we can again have the presence of the Sheriff's Winnebago at the St. Patrick's Parade on Sunday, March 17th.

• Unfinished Business

- 1. Circle Center Rumor has it that a tenant is taking over the BI-LO location. There are leases being signed. The Wild Wings building is still standing. The town has stated that the parking spaces may be used for Coligny area employee parking.
- 2. Social media Veronica Muir is doing a fabulous job with the Facebook page. There are more than 500 followers and photo submissions are popular. Comments are positive.
- **New Business:** David Ames, who the Ward 3 representative (Forest Beach, Shipyard, Wexford, Yacht Cove, Long Cove, Spanish Wells), is not seeking another term on Town Council. A couple of people have expressed interest in running for his seat, but no official applications have been filed. We will certainly invite all candidates to our annual meeting in October to ask Forest Beach questions. There seems to be a lot of disagreement on Town Council concerning town priorities.
- **Membership comments:** Karen Lasko (54 NFB Dr) When will beach nourishment begin and end? There will be a schedule published for 2024-2025. There are not a lot of companies that do this type of work, and they make the schedule. The beach will be renourished in phases, and it could affect tourist season and turtle nesting season.
