## Women's History Month Jan Kuehnemund Memorial Custom Guitar Contest

## **Rules & Waiver of Liability:**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility: This Contest is open only to those who sign up at <a href="http://www.bolteddown.net/contest">http://www.bolteddown.net/contest</a>, who are 18 as of the date of entry and are either female by birth or live their normal lives as a female. The Contest is only open to legal residents of the continental United States and is void where prohibited by law who have not now nor ever had a recording deal and/or guitar endorsement. Employees of Bolted Down, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees, are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations.
- 2. Agreement to Rules: By participating, the Contestant ("You") agree that you have affirmatively reviewed and accepted, and agree to be fully unconditionally bound by, these Rules, and You represent and warrant that You meet the eligibility requirements.
- 3. How to Enter: The Contest must be entered by submitting an entry using the online form provided at <a href="http://www.bolteddown.net/contest">http://www.bolteddown.net/contest</a> and uploading of this completed entry form. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Bolted Down Custom Guitars. All entries must contain a youtube.com like of a minimum forty-five (45) second and maximum sixty (60) second video of the contestant playing an original piece of music on a guitar (guitar solo).
- 4. Prizes: The Winner of the Contest (the "Winner") will receive a guitar customized by Bolted Down Custom Guitars. Bolted Down Custom Guitars will work with the winner to customize the guitar to the winner's preferences with an approximate retail value of \$1,500 (including shipping costs to the winner's location). Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by Bolted Down Custom Guitars. No cash or other prize substitution shall be permitted except. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for Bolted Down Custom Guitars to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by

law. Winner further agrees to supply Bolted Down Custom Guitars with photographs of the winner with the prize, taken at the winner's expense.

- 5. Odds: The odds of winning depend on the number of eligible entries received.

Winner Selection and Notification: Winner will be selected by a panel of judges who will be evaluating the entries on creativity, technique, musicality and other intangibles at the sole discretion of the judges. Judge's decision is final and without unchallengeable. Winner will be notified by email within seven (7) days following selection of Winner. If Winner cannot be contacted, is ineligible, fails to respond within seven (7) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release (if required), the prize may be forfeited and an alternate Winner selected. Bolted Down Custom Guitars will be the sole judge of the Winner's qualification. Prize is a customized instrument and Bolted Down Custom Guitars makes no promise of a specific delivery date.
- 7. Terms & Conditions: Bolted Down Custom Guitars reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the contest for any reason. In such case, Bolted Down Custom Guitars may (but is not required to) select the Winner from all eligible entries received prior to and/or after such termination or suspension. Bolted Down Custom Guitars has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering.
